Permission For Medical Treatment, Photograph/Video Notice, and Release and Indemnity

My permission is granted for the camp or event director, church official, any camp or event staffer, or adult present or in charge of first aid, to obtain necessary medical attention in case of sickness or injury to me or my child. Also, I understand that as a Participant, I or my child may be photographed or videotaped during normal camp or event activities, and these photos/videos may be used in promotional materials. I, the undersigned, do hereby verify that the above information is correct, and I do hereby release and forever discharge the Florida Baptist Convention, Lake Yale Baptist Conference Center, the Church, camp or event sponsors, Lifeway Christian Resources of the Southern Baptist Convention, Common Grounds, and their employees ("Released Parties") from any and all claims, costs, demands, actions or causes of action, past, present or future arising out of any damage or injury in connection with my or my child's employment by or participation in this camp or event. I agree to indemnify the Released Parties for any and all claims, demands, damages, injuries, costs, suits or causes of action, past, present, or future, arising out of or caused by myself or by my child while participating in this camp or event or while on property leased or owned by any of the Released Parties.

Assumption of Risk. I am aware of the risks associated with participation in the above event and do hereby voluntarily assume full responsibility for any risk of loss, property damage or personal injury, including death, that may result from participation in event activities.

Recreation—The recreation programs at summer event venues strive to offer fun, safe, and challenging activities that engage the whole person—body, mind and soul.

Program staffs are trained and as a team committed to your rewarding experience with safety as their highest priority. However there are inherent risks to participation in recreation activities, including but not limited to, initiative games, high and low challenge rope course, outdoor education, paintball, and aquatics. You could experience any of the following—elevated heart and respiratory rates, uncomfortable group dynamics, climbing or descending unpredictable and possibly slick or uneven terrain, crossing narrow wires and logs, jumping, running, climbing/descending steep rock faces, traveling long distances in remote settings, carrying weight on your backs and shoulders, unforeseen forces of nature or weather, any of which could result in injury/illness that could result in loss of life, limb, and/or property.

Understanding. I represent and acknowledge that I have completely read and understand this document and all its terms and all matters referred to herein, and I signed voluntarily as my free act and deed, that I have had an ample opportunity to obtain the advice of counsel and that, by signing this document, I understand that I am relinquishing legal rights and remedies that may have otherwise been available to me. I understand that this Waiver and Release shall be construed as broadly and inclusively as is permitted by applicable law and agree that if any portion of this document is held invalid, the remaining portions shall continue in full force and effect. To the extent the restriction on filing lawsuits is deemed unlawful, I agree to submit any Claims to a Christian conciliation/arbitration organization for binding resolution.

CAMP RULES AND REGULATIONS

Because of my desire for growth and maturity in Christ through the opportunity of CAMP, I am in agreement and will submit to the following guidelines. I fully understand that the violation of these rules will result in my immediate return home at my own expense.

1. Students must dress appropriately and with Christian modesty in mind. Appropriate shorts will be permitted all day. This means shorts that are AT LEAST FINGER TIP LENGTH. No sleeveless clothing during worship, and no tight fitting apparel (i.e. tight dresses, mini-skirts, gym shorts, etc.) is permitted at any time. No clothing will be permitted that exposes your midriff area or promotes tobacco products, alcoholic beverages, racism, hatred or suggestive messages. Dress codes will be enforced by the students' individual chaperones.
2. Girls must wear one-piece swim suits or dark colored t-shirts over their swim suit. You need to have cover-up walking to the pool or lakefront area. Boys must wear a t-shirt at both the pool and lakefront area.
3. Attendance at all meetings and participation in team recreation **is required** for everyone.
4. Participants must not use personal vehicles for any reason, or leave campus without first contacting the CAMP Administrative office.
5. Students are not allowed off campus. Once the student is registered, they may not leave campus until checkout, unless an adult signs them out in the CAMP Office.
6. Scheduled times for room checks and curfew must be obeyed without exception.
7. During CAMP, participants must submit to the direction and supervision of our CAMP staff, especially those assigned to your particular housing area.
8. Students MUST bring with them Bible, pillow, pillow cases, bed sheets, towels, soap, shampoo, toothpaste/brush, appropriate clothing, sport gears, spending money for Snacks.
9. Fireworks, firearms, knives, or any other kind of weapon, alcohol, drugs, or any form of tobacco are NOT allowed. These items can be destructive to you and those around you. Also, DO NOT BRING skateboards, water guns, airsoft guns, video games, laser pointers, DVD players, tablets of any kind, laptops, or televisions. Also, paint is not allowed in the hotel rooms or cabins.
10. Any form of Public Displays of Affection (PDA) is not allowed. This is a week to work on your relationship with God.
11. Participants must wear nametags at all times. There will be a replacement fee of \$5 if lost.
12. Ordering food to be delivered on campus is forbidden. In fairness to everyone, we will eat in the campus cafeterias. Snacks and Late Nite Bites are available to purchase in the Snack Shack. CAMP T-Shirts will also be available for **\$10.00** each.
13. Cell phones are not allowed in classrooms or worship services. In order for cell phones not to be a distraction, students are encouraged to leave their cell phones in their rooms.
14. Lake Yale Baptist Conference Center facilities are to be treated with respect. **Any damage will be charged to all students booked in that room or cabin.**

I understand that these guidelines are necessary for me to maximize the spiritual opportunities of the week. Having read them, I willingly commit myself to abide by them.
