Standing Rules

Florida Baptist State Convention

Messengers are advised that the procedural rules that will govern the business sessions of the annual meeting are defined by the Bylaws, Florida Baptist State Convention, specifically Bylaw 1, titled "Rules of Order." The highlights of those procedural rules are as follows:

- **A. Rules of Order:** The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the State Convention in all cases to which they are applicable and in which they are not inconsistent with the Bylaws of the Florida Baptist State Convention and these standing rules.
- **B. Standing Rules:** The Committee on Order of Business shall act as the Committee on Standing Rules in presenting any standing rules (parliamentary and nonparliamentary procedural rules) for consideration by the State Convention during the first session of the State Convention meeting.
- (1) The Committee on Order of Business, at the time it presents the program for adoption, shall call to the attention of messengers present, the existence of the following permanent rules that shall govern the conduct of business during the State Convention meeting:
- (a) For admission to the assembly hall, under certain conditions and at the discretionary order of the State Convention president, to facilitate identification and seating, messengers, visitors, and others may be required to wear the badge issued by the Registration and/or the Credentials Committees.
- (b) A resolution offered by an individual messenger(s) shall be in writing, signed by the maker who shall be a registered messenger to the State Convention, and shall be delivered directly to the desk of the Recording Secretary, after the resolution has been introduced. The introduction of a resolution shall be limited to only the title and/or topic of the proposed resolution being presented, with neither further explanation nor discussion. (See Guidelines for Handling a Motion of Resolution.)
- (c) No messenger shall speak in debate more than twice on the same question during the same session, for no longer than three minutes each time, without the permission of State Convention messengers who may grant such a privilege by a two-thirds vote without debate.
- (d) All reports and other material for the permanent record or printed proceedings shall be in typewritten form and, immediately on presentation, shall be delivered to the Recording Secretary.
- (e) Nominations for each elected office to be filled by the State Convention shall be limited to one nominating speech of three minutes for each nominee. Nominees for any elected State Convention office shall be: a registered messenger; shall have agreed to be nominated; and shall be present on the platform at the time in which they are nominated.
- (f) When more than one candidate is nominated for any convention office, a written ballot shall be taken from all registered messengers present and voting. The Teller's Committee, appointed by the State Convention President, shall collect the ballots, count the ballots, verify and certify the voting results. The chairman of the Teller's Committee shall provide to the State Convention President, on a timely basis as soon as is practicable after the respective vote, a written report on voting results. The report shall include the actual number of ballots cast, the number of votes received by each candidate, and the number of invalid ballots collected.

(2) All motions, resolutions and memorials, except those proposed by the State Board of Missions or by standing committees, and all recommendations made in reports of officers or committees of the State Convention, shall be referred to the Committee on Order of Business. The Committee shall determine appropriate disposition of these motions, resolutions and memorials. Motions of resolutions and recommendations proposed by the State Board of Missions or by State Convention Committees shall be presented by the Board or proposing committee directly to the State Convention, at a time designated by the Committee on Order of Business.

Guidelines

for Handling a Motion of Resolution

On November 13, 2000, the Administrative Committee of the State Board of Missions approved the following procedures for handling a motion of resolution.

- 1. During the first Miscellaneous Business session, a person introduces his/her motion or resolution by stating the subject. The presiding officer will seek to clarify, if necessary, the intent of the motion/resolution.
- 2. A written copy of the motion will be brought to the Recording Secretary's desk located at the front edge of the platform.
- 3. The Committee on Order of Business will set the time for discussion of the motion or resolution. If there is no other miscellaneous business scheduled, the committee could recommend consideration at the time the motion is made.
- 4. The time for discussion of particular motions/resolutions will be announced by the presiding officer.
- 5. At the appointed time set by the Committee on Order of Business, the maker of the motion will be permitted to speak to his/her motion/resolution. As a motion/resolution it will be considered by the Convention body, which may choose to debate, amend, table, refer, approve or defeat the recommendation.
- 6. The presiding officer, in consultation with the parliamentarian, will determine if a motion can be acted upon immediately, rule the motion out of order, or refer it to the Committee on Order of Business.

Haitian Church Planter Has Heart To Reach Southwest Florida

LEHIGH ACRES-Originally from a small community in southeast Haiti, Daniel Garcon has seen areas that desperately need the gospel – and he believes southwest Florida is one of them.

After accepting a call to ministry in 2005 and realizing the importance and need for training, Garcon began church planting training with the Florida Baptist Convention and immediately fell in love with the southwest Florida region.

However, after serving at a church in Naples, the young man left the Sunshine State to spend a few years in Boston with his family.

"While I was in Boston, I knew exactly where God wanted me to be," said Garcon. "I loved Boston, but I knew God was calling me to do a great work for Him in Florida."

Describing himself as "having joy only when doing God's will," Garcon knew his burning desire to begin a new, fresh work in southwest Florida was not going to burn out anytime soon. He returned to Florida in 2018 and immediately began serving Haitian churches in the region.

Convinced that God only needs a few faithful and willing hearts to do the work of ministry, Garcon and nine others planted Christ Center Fellowship of Lehigh Acres in June 2019 while going from house to house.

The congregation has a heart to reach the growing Haitian community in Lehigh Acres, a small town located 20 miles east of Ft. Myers. It seeks to be a "Christ-centered church" that is all about "teaching God's Word and making disciples," Garcon said.

To teach his members the importance of prayer as a spiritual discipline, Garcon has dedicated time to sharing the biblical mandate for prayer and how to spend more time in intentional prayer. Christ Center Fellowship gathers as a church family every Friday evening for an intimate time of corporate prayer.

"We spend much of our time praying for individuals and families in our church and have seen radical life change," Garcon said. "Prayer is for our sanctification."

Perhaps the most distinguishing mark of the church plant is a longing to reach the lost and unchurched in the community. Not wanting to limit its ministry, the church offers both Creole and English-speaking services in a storefront they now rent in the center of town. The church also plans on mailing gospel tracks and information to homes throughout their community and plan, what the pastor calls, an "evangelism explosion."



Garcon, who serves bivocationally, intends to partner alongside other local churches in making personal phone calls and using old fashioned door-to-door evangelism methods to witness and share the gospel across the community.

"We are going to keep recruiting people to come to know Christ until He comes back," Garcon said.

Garcon is careful not to be "ministry heavy, but servant driven." With a goal not to have ministries for the sake of having ministries, the church has focused on a streamline approach to simply encourage members to serve when and where the need arises.

"We don't want to have various ministries for the purpose of having a lot of ministries," he said. "We must see a great need for that ministry."

Now with more than 20 in attendance, Garcon's next steps are to encourage and equip his members to serve. Garcon has encouraged existing members to serve and attend the church's weekly prayer ministry, small groups, new members class and the praise and worship team.

"We have seen such a transformation in the church and the lives of the people," he said. "Their testimony has confirmed to me that we can make an impact in our community."

John Voltaire, Florida Baptists' Haitian church catalyst, commended Garcon for his desire to reach his community. "Pastor Garcon loves the Lord and has a heart for ministry," he said.

Garcon has a passion for Florida Baptist churches to cooperate and point a lost and dying world to the life they can find through placing their hope and trust in Jesus. He serves on the Church Relations Team for the Royal Palm Association.

"I believe local churches need to be united," he said. "Local churches need to reach as many people as we can, while we can. Let's get busy for the Lord, let's get to work!"

Burmese Pastor Faithfully Serves God At Jacksonville Emmanuel Baptist Church

They were a small group of Burmese believers, not yet an organized church, meeting weekly in an apartment in Jacksonville to worship and pray in their Falam dialect. And they were hoping that God would provide a man that could preach, teach and shepherd them in their language.

In July, 2014 a man in the group who knew Daniel Thang, heard that Daniel and his family had just arrived in America and were living in Illinois. He connected with Daniel through Facebook and asked him to come to Jacksonville to pastor the fledgling group of Burmese believers.

"The group took up a collection for my family to move here. It's a wonderful and miraculous work by God to show His mercy and one of my greatest blessings to come here and establish a church where people actually need it," said Daniel.

Daniel relocated to Florida with his wife and 3 children in September, 2014 and Jacksonville Emmanuel Baptist Church officially began in October.

They continued meeting in an apartment until Jong Oh Lee, pastor of the Korean First Baptist Church of Jacksonville invited them to use rooms in his church for worship; in 2015 they began meeting at the Atlantic Boulevard building and still meet there today.

According to Thang, there are about 1,000 Burmese people in the Jacksonville area.

"The Burmese people have many dialects, some states in Burma speak different dialects. Many cannot speak English nor can they speak Burmese, the common language of Burma," says the pastor.

Because of the various dialects, there is a lack of communication. "Burmese people cannot communicate [with each other] and it's hard to relate," said Thang.

That is why, according to Thang, there are 10 Burmese churches in Jacksonville each with their own dialect.

Born in Burma (Myanmar), Thang was born again in 1984, yielding his life to Jesus Christ as LORD and Savior when he heard the gospel preached at an evangelistic crusade.

A year later he was called to the ministry and attended a Bible college in Falam, his home town.

After serving churches in Burma, then in India for 15 years, he and his family were ready to return to their home country in 2014. But due to civil unrest there, they could not go back.



Filing for refugee status with the United Nations, "by God's will we came to Illinois," Thang shared. From there they moved to Jacksonville.

There are now 47 members of Jacksonville Emmanuel Baptist who worship together on Sundays at 12:30, along with 24 children.

"We have a plan to have our own church building," shared the pastor, and to date they have collected \$11,000 toward purchasing their own facility.

Thang has seen God at work at Emanuel as many can now pray publicly in front of others and have also learned to share their testimony, able to tell others what God has done in their lives.

The church has a strong women's fellowship that meets twice a month, led by Thang's wife, Lai Eng Mawi. And the congregation sends monthly support to a missionary family who serve in a Buddhist area in Mandalay, the second largest city in Burma.


Faithfulness is a hallmark of Thang's life as he has followed God from Burma to India to Florida.

"I am so thankful for men of God like Pastor Daniel who continue to serve faithfully," says Craig Culbreth, east catalyst, Florida Baptist Convention. "Even during the pandemic the church managed to continue to hold worship services. He is a model of faithfulness."

Daniel acknowledges that God has led him and his family through difficult times. "I will always trust God despite circumstances," he says.

Romans 10:11 is the verse that gives him confidence that if God is with him, "no one can put me or my family to shame, our needs will always be met by God," declares the pastor.

Church Remains Hopeful Despite Hurricane Setbacks

PANACEA-While not noticeable to all, the communion table in front of the pulpit at First Baptist Church in Ochlockonee Bay shows the signs of the two hurricanes that flooded the church in the past 16 years.

There's the high watermark from Hurricane Dennis in 2005. And there, up a little higher, is the mark from Hurricane Michael in 2018. But these watermarks are not just reminders of the flooding and destruction caused by the hurricanes, they are also a testament to God's faithfulness and provision.

Despite the damages caused by the hurricanes, this small concrete block church – located about 50 minutes south of Tallahassee – continues its mission to the community it serves.

That's why Pastor James Chunn and church members were excited to bring back Vacation Bible School this year after missing it due to the pandemic in 2020. Chunn loves to brag about their VBS and how the Family Night celebration filled the church on its final night.

The bivocational pastor also loves bragging about the smooth and beautiful flooring at the church, the same flooring that children played and performed on all week during VBS. After carpeting was destroyed by Dennis, then replaced and destroyed by Michael, the church just kept its concrete flooring.

Thanks to a grant from the Florida Baptist Convention, the church was able to have its floors redone in recent months with a unique multi-layered coating process for the concrete floor. Not only does it add to the appearance of the church interior but it's also easy to maintain and won't be destroyed should another hurricane flood the area.

"Through the Florida Baptist Convention and all the different agencies and churches, it's truly said that when two or three are gathered in His name, He is there," Chunn said. "No matter how small the church is, He can do great things."

The grant is just one of the ways God has taken care of the church over the years, Chunn said. He can tell story after story of how churches and people from all over Florida came to assist them after both hurricanes:

- The Florida Baptist Disaster Relief team from Chattahoochee who cleaned and sanitized walls and pews after Dennis
 - The church who rebuilt the pulpit stage after Dennis
 - The church who put on a new metal roof after Michael
- The woman who donated her \$10,000 Baldwin organ to replace the one she saw sitting by the road with other storm debris.



Hurricane Dennis brought a storm surge of 6 to 9 feet in 2005, leaving three feet of water in the church and washing away a landmark waterfront restaurant just down the street from the church. The congregation was able to salvage the church's wooden pews after Dennis, but the organ was destroyed, as was the new, recently installed carpeting.

"We were hurt so bad from Dennis," said Chunn, who has the photos to share. "But we didn't miss a single service. An RV park nearby allowed us to use their recreation area for our services. And we held Bible study at a local restaurant."

Hurricane Michael was a Category 5 hurricane when it made landfall in October 2018 at Mexico Beach, about 82 miles west of Ochlockonee Bay. The standing water inside the church was even higher this time, and all the pews were destroyed, as was the donated organ.

That's when one church volunteered to replace the roof. Another church from South Florida sent 100 chairs, 60 of which are currently being used in the sanctuary. The church used part of the grant funds to pay for covers for these chairs, making them look like new.

"This can't be nobody but the Lord," Chunn said of how God has provided for specific needs. "God says trust in me and I'm going to take care of the things you need. For some reason, our Savior wants that little church right there."

The church is currently down to 38 members, but Chunn remains hopeful. For now, he continues to preach on Sunday morning during in-person worship while sharing it live via its Facebook page, like many churches have learned to do during the pandemic. The associate pastor does Bible study on Facebook on Wednesday nights.

"It's great to see that people are watching our little ol' service," he said. "I love Jesus and try to preach the best I can. If I can reach one person out of all those people, then it's worth being online."

As the church has made its way through hurricanes and worked through a pandemic, Chunn said they've learned to trust in God.

"Is it easy? Heck no, but He always come through, sometimes it's right at deadline," he said. "You just have to have patience and be faithful and trust in Jesus."

The State Board of Missions of the Florida Baptist State Convention respectfully submits this 140th annual report of the Board to the State Convention. There are 2,821 churches and missions affiliated with the Florida Baptist State Convention, with a total membership of 839,561.

The State Board of Missions is pleased to present this report to the Florida Baptist State Convention meeting in Lakeland, Florida, November 8-9, 2021. This report covers the period of October 1, 2020, through September 30, 2021.

3. Cancellation of 2020 Florida Baptist State Convention Annual Meeting and Related Actions

On March 9, 2020, Florida Governor Ron DeSantis issued an Executive Order declaring a state of emergency for the entire state due to COVID-19. The state of emergency was extended several times by Executive Order.

On August 27, 2020, the Florida Baptist State Convention officers and State Board of Missions standing committee chairpersons convened via video conference for discussion of the COVID-19 pandemic and the impact it would have on the 2020 annual meeting of the Florida Baptist State Convention.

After discussing the various situations Florida Baptist churches are facing with regathering, the varied levels of churches regathering in each region across our state, the risk for messengers gathering

and many other factors, the convention leadership unanimously voted to recommend the cancellation of the 2020 Florida Baptist State Convention Annual Meeting scheduled for November 9-10, 2020, at the Lakes Church (formerly Church at the Mall) in Lakeland, Florida

While the Florida Baptist State Convention Constitution and Bylaws do not directly specify the action steps and authority for the cancellation of the annual meeting because of an emergency situation such as a world-wide pandemic, the governing documents do however, set forth powers for the State Board of Missions to change the meeting place and/or time of the annual meeting. Additionally, the Board is clearly permitted to act on behalf of the Florida Baptist State Convention ad interim.

During a meeting of the State Board of Missions on September 18, 2020, acting on the recommendation of convention officers, under the authority established in Article 4, Florida Baptist State Convention Constitution, the Board adopted the following:

(1) Revision of Annual Meeting Schedule

That the 2020 annual meeting of the Florida Baptist State Convention be cancelled and the following revised annual meeting schedule be adopted:

5. Gifts to World Missions

6. 2020 Maguire State Mission Offering Report

The 2020 Maguire State Mission Offering was directed by the State Board of Missions toward the singular goal of impacting the strategic mission region of South Florida with additional church planting and revitalization resources.

With the close of the Convention's accounting year on December 31, 2020, a total of \$557,972 was received for the year 2020 Maguire State Mission Offering. The 2020 total represented 79.7 percent of the offering goal of \$700,000. The total number of churches contributing to the offering continued to decline to 481 from the 538 participating the prior year.

7. 2020 Maguire State Mission Offering

On April 9, 2021, the State Board of Missions approved a 2021 Maguire State Mission Offering goal of \$760,000 and directed 100 percent of the offering be allocated to the SEND Network Florida Global Fund for Ministry.

13. Report on Florida Baptist Convention Audit

The audit of the Florida Baptist Convention, Inc., for the year ending December 31, 2020, is presented as an unmodified opinion of the financial statements that were found to be in conformity with generally accepted accounting principles.

14. Report on Florida Baptist State Convention Cooperating Ministry Audits

On August 27, 2021, the State Board of Missions received a report that the Audit Subcommittee of the Finance Committee had examined the audit reports and management letters of the following entities of the Florida Baptist Convention:

16. Financial Assistance: Church Planting and Revitalization and Maguire State Mission Offering

Church Planting and Revitalization grants continue to be a cornerstone focus of the Florida Baptist Convention. The 2021 Cooperative Program budget includes an amount of \$1,850,000 designated for church planting and revitalization. Additionally, during the March 2020 meeting of the State Board of Missions, the Board authorized 100 percent of the 2020 Maguire State Mission Offering be allocated to the Florida SEND Network Global Fund for ministry to churches throughout the entire state of Florida.

The Committee is composed of three State Board of Missions members who serve on a rotating basis, with vacancies to be filled as they occur. On February 25, 2021, the Board received a report that during the period of January 1, 2020, through December 31, 2020, 2 individuals received \$2,000 in assistance through the Ministers Emergency Assistance Program.

It was noted in a report to the Board on April 9, 2021, that during the period of January 1, 2021, through March 30, 2021, there were no persons assisted through the MEAP.

During a meeting of the State Board of Missions on August 27, 2021, the Board learned that 2 individuals received \$2,000 in assistance through the Ministers Emergency Assistance Program from April 1, 2021, through July 31, 2021.

19. Appointment of Investment Subcommittee

25. Florida Baptist Historical Society: Appointment of Board of Directors

The Florida Baptist Historical Society is a non-corporate fraternal organization endorsed by and related to the Florida Baptist State Convention. To carry out its purpose, the Society is managed by a Board of Directors. During the August 2018 meeting of the State Board of Missions, the Board approved amendments to the policy governing the Florida Baptist Historical Society. The new policy called for the Florida Baptist Historical Society Board of Directors to consist of six members, three of which are to be elected by the State Board of Missions, and three who serve as permanent members: the executive director-treasurer of the Florida Baptist Convention, or his designee; Curator of The Baptist Archives, The Baptist College of Florida; and the secretary-treasurer, Florida Baptist Historical Society. Other directors serve on a rotating basis. It is the responsibility of the State Board of Missions to elect the directors. Historical Society Director

David Elder rotated off in November 2020 and was not eligible for re-election. On February 26, 2021, the State Board of Missions elected Donald Minshew, Plantation, to serve on the Florida Baptist Historical Society Board of Directors for the term ending December 31, 2023.

On December 31, 2021, FBHS Board member Arlene Vause, Sopchoppy, will complete an unexpired term and is eligible reelection. During its meeting on August 27, 2021, the State Board of Missions elected Mrs. Vause to the Historical Society Board for the term ending December 31, 2024.

On April 9, 2021, the Board received an update on the previous Board action.

The latest data informs us that Florida has over 500,000 individuals classified as immigrants, over 150,000 individuals classified as migrants, and over 14.5 million international travelers each year. Our goal as Florida Baptist churches is to be a Gospel witness as we share the salvation of Jesus Christ with as many of these individuals as possible.

Led by Mission and Ministries Lead Catalyst Myles Dowdy, a Florida Baptist Convention team from multiple areas of discipline joined together to research what churches were already doing to minister to immigrants in our state. This team included Steve Baumgardner, Cindy Bradley, Misael Castillo, Patrick Coats, Al Fernandez, Marc Johnston, Emanuel Roque, Nathan Schneider and John Voltaire. The group met on multiple occasions and engaged with church and ministry experts that are actively involved in ministry to internationals and immigrants living in our state. Some of the ministry focuses that already exist include:

English as Second Language Classes Citizenship Classes Tutoring Food, Health and Clothing Resources Legal Resources Skill Development Financial Classes Refugee Asylum

The exciting and overwhelming opportunity for ministry motivated the team to create a new resource on the Florida Baptist website entitled Internationals/Immigrants (https://flbaptist.org/immigrants-internationals/). Within this resource is current information about ministries to our international and immigrant communities located in Florida. In addition, the site provides numerous "how to" resources for churches. These resources are designed to help churches minister to internationals in the areas of immigrants, migrants, international travelers and human trafficking. As God continues to bring to our state new international neighbors the information and resources on this site will change and be updated.

Beyond the resources made available through the website, convention staff will be working to develop and expand other training, conferencing and networking opportunities to further encourage and equip ministry leaders in the development of Immigrant/Internationals ministry.

28. Authorization for Florida Baptist Financial Services to Sell Florida Baptist Retirement Center

During the State Board of Missions meeting on April 9, 2021, the Board learned that Florida Baptist Financial Services under the leadership of Rick Wheeler, president and CEO, had recently undergone a process of evaluation as it pertains to the Florida

Baptist Retirement Center. This process culminated in a decision to sell the property and in which they received a bona fide offer for purchase with anticipated closing within 120 days.

Pursuant to the Bylaws of the Florida Baptist State Convention, the State Board of Missions shall review and approve requests to sell or transfer ownership of any real property proposed by a cooperating ministry of the convention and then recommend approval to the messengers of the Florida Baptist State Convention. Additionally, given the timeline of the proposed sale, it was necessary for the State Board of Missions to act upon this request on behalf of the messengers of the Florida Baptist State Convention ad interim of the annual meetings. Article 4 of the Florida Baptist State Constitution delineates these responsibilities.

Consequently, on April 9, 2021, the State Board of Missions, acting in its capacity for the messengers ad interim of the annual meeting, authorized the directors of Florida Baptist Financial Services to proceed with the sale of the Florida Baptist Retirement Center; with the intent that proceeds generated from the sale be dedicated to establishing a fund which would directly benefit retiring Florida Baptist pastors in need and to honor them for their years of service to Florida Baptist churches, and to fund additional ministries that will bless Florida Baptist retirees.

29. Authorization for FBCH Land Holdings to Sell 16.2 +/- Integral Acres of Jacksonville Campus

During the May 2020 meeting of the State Board of Missions, the Board approved a recommendation by FBCH Land Holdings (FBCH LH) to sell 6.5 +/- integral acres of its Jacksonville Campus to the First Baptist Academy of Jacksonville (FBA). The sale price, for a total of 21.5 +/- acres, is \$1,500,000. FBCH LH is currently leasing the land to FBA, as the sale of the integral acreage was contingent on approval by the Florida Baptist State Convention. Subsequently, FBCH LH has agreed to sell an additional 9.7 +/- integral acres of the Jacksonville Campus to FBA. The sale price, for a total of 9.7 +/- acres, is \$3.5 million. FBCH LH is currently leasing the land to FBA under a second 99-year lease.

On April 9, 2021, the State Board of Missions, acting in its capacity for the messengers ad interim of the annual meeting, authorize the directors of FBCH Land Holdings to proceed with the sale of 16.2 +/- integral acres of its Jacksonville Campus to the First Baptist Academy of Jacksonville with the expectation that proceeds generated from such sale will be dedicated to Phase 2 of the FBCH Jacksonville Campus Master Plan.

30. State Board of Missions Policy Governing the Convention's Release in Reversionary Interest in Real Property

During a meeting of the State Board of Missions on April 9, 2021, the Board adopted a "Policy Governing the Convention's Release of Reversionary Interest in Real Property." The purpose of this policy is to establish how the Florida Baptist Convention responds to requests for the release of reversionary interest the Convention has in various real property around the state. Historically, the majority of the Convention's reversionary interests in various church properties came about as a result of loans and grants issued by the Convention.







STATE BOARD OF MISSIONS Recommendations to the Florida Baptist State Convention

2022 Florida Baptist Convention Budget

The State Board of Missions recommends that the Florida Baptist State Convention adopt the year 2022 Cooperative Program Basic Budget of \$29,150,000 based upon the following distribution and the general detail as noted in the attached budget document:

(a) That all Cooperative Program income receipts be distributed on the following percentage allocation:

Southern Baptist Convention causes 51.00% Florida Baptist Convention causes 49.00%

(b) And that the Cooperative Program Basic Budget designated for Florida Baptist Convention causes (or 49% of total Cooperative Program income) be distributed on the following basis:

> Programs of Mission, Ministry and Support \$12,474,500

Cooperating Ministries

The Baptist College of Florida \$1,320,000 Florida Baptist Children's Homes \$912,000 Lake Yale Baptist Conference Center \$160,000

(c) That all Cooperative Program receipts received by December 31, 2022, and which are in excess of the budgetary requirements specified within the 2022 Cooperative Program budget shall be designated as Cooperative Program Excess Budget funds. Furthermore, we direct 51% of such excess funds be immediately distributed to the Cooperative Program of the Southern Baptist Convention. Further recommendations and subsequent Board action on the distribution of the remaining 49% of Excess Budget funds shall be in keeping with the State Convention's Business and Financial Plan [Bylaw 16, B (3)(a)(b), Bylaws of the Florida Baptist State Convention].

Eight-Year-Old Proves Any Age Can Impact Missions

TAMPA— Eight-year-old Adison Bugbee raised more than \$200 for the Lottie Moon Christmas Offering, proving you should never underestimate the next generation of world changers.

In early December, Adison's grandmother, Carol Bugbee, shared the story of Lottie Moon with the children of the Bell Shoals Baptist Church's Palm River campus.

Carol Bugbee had once led the Woman's Missionary Union—an auxiliary of the Southern Baptist Convention Lottie Moon was influential in founding—at the campus where she discipled women and led mission projects. As she spoke about Moon's heart for the women and girls of China, young Adison was moved to go all in.

After collecting more than \$100 from her neighbors, friends and family, Adison arrived at church the next week with her collection container literally about to fall apart. The next week, someone gave another \$100 for her cause.

Coming from generations of women in missions, Adison lives out 1 Tim. 4:12 by loving her neighbors. "I just really wanted to help people in need and help Lottie reach more people for Jesus," Adison said about what drove her to talk with friends, family and neighbors about missions.

Her grandmother described the young girl as, "a very loving and caring child. She is tender-hearted and empathetic. When Adison hears of someone in need, she is without hesitation ready to help."

Former International Mission Board missionaries Kenny and Teresa Bass now lead the Palm River campus with a heartbeat for reaching their local community through gospel-driven mission work. From monthly clothing drives to weekly meal deliveries for families in need, this church sets the tone of mission-mindedness for its youth.

Church member Kim Almand was touched by Adison's spirit and decided to give. "I saw how Adison was so interested in Lottie Moon. Knowing how instrumental her grandmother, Carol, was in building up the women of our church in missions, I really wanted to support her. We wanted to encourage Adison to work toward missions and have personal insight to the impact her contribution would make. "

As the children's director at the campus church, Teresa Bass wanted to raise awareness of Lottie Moon and what missions is because every child is capable of being used by God.

"It is easy for adults to discount children and the things they are able to learn, understand and do because of their age," she said.

Jesus took the faith, bread and fish of a young boy and used it to feed more than 5,000 women and children. "It is never too early to invest in children. You never know where God will call them in the future. Despite their age, God can still use them to make an impact in ministry. All it takes is a spark to start a fire and the same is true for our children," Bass said.

"This little girl comes from a long line of women who were former GA's and one who has even served on the mission field, but I cannot help but wonder what God has in store for my little Adi," Bass continued. "Future missionary? Maybe! Only God knows what comes from small seeds planted in the hearts of our children."

Russian-Speaking Church Plants Satellite Congregation In Neighboring City

FORT LAUDERDALE — Boca Raton's Russian-speaking Bible Church is just over a year old. But its newness has not stopped the church from sending a group to neighboring Ft. Lauderdale to reach the underserved Russian-speaking community there with the claims of Christ.

"There are many people in the Boca Raton and Ft. Lauderdale area who speak Russian, but it doesn't mean that they are necessarily Russian," explained Daniel Naberezhny, Bible Church pastor.

"People from countries that were once part of the Soviet Union also speak Russian and we want to reach them and give them a place where they can read and study the Bible in their own language," he said.

More than 200,000 Russian-speaking people live in Miami-Dade, Broward and Palm Beach counties, according to the latest data from the U.S. Census. Russian Town Magazine noted that "Florida is the second largest Russian community in the U.S. with rich culture and net worth."

Bible Church meets for worship on the campus of Boca Raton Community Church. The church plant is thriving and growing and has attracted Russian speakers from surrounding areas, including Ft. Lauderdale.

Yuriy Karolyuk, a member of Bible Church, urged the congregation to begin a similar satellite ministry in Ft. Lauderdale to reach the Russian-speaking community there. He was sent to lead that group.

He began working with Al Fernandez, Florida Baptist Convention's southeast regional catalyst, who facilitated a connection between the Russian group and Immanuel Baptist Church. Immanuel opened its arms to the fledgling congregation.

"Our church is very diverse with families representing South America, Europe, the Caribbean, and many more countries," said Carol Vidal, Spanish pastor at Immanuel. "We are a very mission minded church; a very united church that loves to serve."

Immanuel's lead pastor, Larry Brister, was once a mobile church pastor and knows the challenges new congregations face in finding a place to meet for worship.



"I have a heart for pastors who are planting and don't have a place to meet," said Brister. "I reached out to Al and told him that we could help pastors out who didn't have a place to meet."

The Bible Church satellite is currently meeting in the Immanuel facility rent-free, and the pastors have already talked through accommodations as the group continues to grow. Beyond providing space, the Boca Raton church and Immanuel plan to host events together to bless the communities surrounding each church.

"The area around Immanuel has become diverse with lots of Haitians, African Americans, Ukrainians, Polish, and Russians moving in," said Vidal. "Now, there is more traffic... and the church is more visible, and more people are coming. The food pantry and clinic also contribute to the visibility in the community."

Vidal said Bible Church is also welcomed to make use of the clinic and food pantry in their ministry to the Russianspeaking community.

On Wednesday May 12, the Ft. Lauderdale group of Bible Church met for their first Bible study with an attendance of 16 adults and five children. Of the adults, 10 are non-believers.

"For now, this group is the extension of our church over there," said Nabernezhy. "We are excited to see another place for God's people to come together and study the Bible in their native language."

"The main goal for us is for people to be born again," he continued, "and it doesn't matter if they stay with the Russian-speaking church or choose to go to an English-speaking church."

Prison Ministry From The Inside Out: How One Pastor's Personal Prison Experience Gives Him A Heart For The Incarcerated

EASTPOINT-Kory Gordon was introduced to drugs at an early age by his stepfather. By the age of 12 he tried his first pain medication and quickly became addicted.

"That opened up the doors for a long, hard life," said Gordon.

When he was 22, the Hayhurst, Ga., native moved to St. Petersburg and found a six-figure job at a power plant. But everything changed when he started dealing drugs to coworkers and landed in jail with 11 felonies. He eventually was sentenced to 13 years behind bars.

Seven years into his sentence, he was moved temporarily to Pinellas County Jail. When he arrived, he found a Bible under his bed.

As he was reading, "My eyes were opened. I realized all my problems, crime, drama and drug abuse came from God not having a place in my life," Gordon said.

Pushing the Bible aside, he was not quite ready to surrender his life to God. He found another book he thought was secular in content, but it was the testimony of how a woman was delivered by God from witchcraft.

As he was reading, the Gordon recalled, he jumped up from his bed and said, "God, you can have all of me—but I need you to free me from the slave master and the addiction."

From that moment Gordon's life looked different. He came back to his old cellmates with a Bible in his hand and immediately began ministering to others. He started a Bible study and became involved in the prison's chapel services.

One Sunday he was able to share his testimony during chapel. That service opened doors for Gordon, while still serving time, to preach a weekly service. He discovered because he had lived through the struggles many of the men were facing, he could relate in ways others could not.

When word got out about his testimony, a Tallahassee church asked the young man to speak the day after his prison release. He traveled the Panhandle region sharing his testimony and preaching at churches. Not long after

that, First Baptist Church in Eastpoint invited him to be their pastor, where he has served for two years.

Now 38, Gordon and his wife Kasey, who he met and married while he was still incarcerated, are expecting their first child.

"Pastor Kory Gordon and his wife are living the transformed life as they minister together to the community of Eastpoint," said Lewis Miller, Florida Baptist catalyst for the West region.

"They are loved by all who know them and are keenly aware of the needs of their Eastpoint mission field. We are grateful for their leadership and partnership in reaching those who are hurting."

Because of his experience, Gordon has a special place in his heart to minister to the incarcerated. While serving full-time at the coastal community church located on Apalachicola Bay, he also takes time to minister to the people God has laid heavy on his heart.

For the past two years, Gordon has been invited by the Franklin County Sheriff's Office to speak at its annual Thanksgiving Service that includes a special meal and worship.

Prior to the COVID-19 outbreak, he traveled every other week to the Franklin County Jail to preach and made weekly trips to Promised Land Ministries Lighthouse recovery center in Crawfordville to minister to those in rehab there.

As he shares the gospel with prisoners, Gordon has seen lives radically changed. He recalled one married couple who was experiencing devastation in their lives and marriage from a meth addiction. God forever impacted their lives through Gordon's ministry behind bars.

"Fast forward eight months and they are sober, in church, with jobs," Gordon said. The husband was even being considered for a job at NASA. "It's a great story of transformation."

Although some are fearful walking into a jail to minister to people, the opposite is true, he said.

"People may be intimidated going in, but people in prison are way more receptive to the gospel. There's nothing like ministering to people who are broken. It's hard to tell successful people they need Christ but for broken people, their heart is already torn open."

Church Planter Offers Restoration And Hope In Downtown Historic Sanford

SANFORD—When Arthur Gonçalves first met Adam, he was pushing a cart in downtown Sanford. When offered a meal and prayer, he accepted both and by the end of the night, he also accepted Jesus Christ as his personal Savior.

Now 10 months later, Adam is sober, has a job and goes out regularly to evangelize on the streets where he once pushed his cart.

Adam's transformation was just one of the lives changed through Gonçalves' ministry in the Central Florida community.

With a heart for marginalized people and a desire to plant a church in downtown Sanford, Gonçalves believes God has called him to help restore people from all walks of life to God through faith in Jesus Christ.

"It is messy coming alongside people—but that is our ministry—spiritual, mental, emotional and physical restoration of others," said Gonçalves who started the ministry in downtown Sanford in 2019.

The ministry began as he led a group from the Church at Heathrow in Sanford to serve at a downtown homeless center. Soon afterwards, the center's leaders asked him to return and lead Bible study every Monday evening for a year.

Through that experience, God began working on his heart and that of his wife's. "We saw that there was a great need for mercy ministry but also for preaching and gospel ministry," said Gonçalves.

Feeling led to pursue starting a church and downtown ministry, the young man's first step became praying for Sanford.

A local downtown restaurant, The Colonial Room, offered the use of its banquet hall for weekly prayer gatherings which began in January 2020 with six to seven people.

In May he joined a local Rotary Club where members began sharing needs of the local police and elderly in the community. "We helped the police department give away gifts to children in need during Christmas. We also help our elderly with groceries and with home and lawn maintenance on some occasions," said Gonçalves.



After meeting the needs one at a time, it turned into "full blown outreach ministry."

The ministry team grew to 20-30 people as they began providing weekly meals, clothing and hygiene kits to those in need in downtown Sanford.

Local businesses heard about their efforts and four restaurants offered to cover the cost of preparing 50 meals each week.

Since June, meals have been prepared every Thursday and served in the banquet room to those in the neighborhood who come to join them. As many as 35 people have attended and stayed for worship.

Each week, a sister church, Orlando Baptist Church, loans the team a 15-passenger van to use to deliver meals to local homeless sites and in the Goldsboro neighborhood. They now anticipate the van's arrival.

Even before the church has launched, they have seen God at work. This past year six people have come to faith in Christ, and two have been baptized, including Adam.

After he was invited to attend the service at the restaurant, "Adam came, repented and confessed Jesus," said Gonçalves. "He also stood up and confessed his alcohol addiction, asking for help."

That night among the men in attendance was the director from The Recovery House of Central Florida, a faith-based community providing transitional housing and support services for the homeless and those with addictions.

Adam was admitted into the program at The Recovery House the next day and is now 10 months sober and has a job. He goes out in the community with Gonçalves' team to help evangelize and is part of the church planting team.

"We've had multiple accounts of similar testimonies, reaching people who are marginalized," said the young minister.

Gonçalves plans to launch Restoration Church in January 2022 at Hamilton Elementary School in the heart of the impoverished downtown area.

"There are 633 students at the school and 92 percent of them receive a free or reduced cost lunch," shared Gonçalves. "There are lots of needs to be met at the school itself where the average income for a family of four is \$30,000."

Through the North American Mission Board, SBC, the father of four is now a church planter, part of the Send Network Florida. Central Baptist Church in Sanford, is the sending church.

Alan Brumback, pastor of Central Church, commended the ministry. "We are so excited to have Arthur and his family serve in our city to reach our community for Christ. Arthur has a contagious passion for sharing the gospel and making disciples of all people and we are excited to be a part of the journey," he shared.

The Committee on Nominations of the Florida Baptist State Convention presents the following report for consideration and action by the Florida Baptist State Convention, November 8-9, 2021.

Persons listed in the sections "Nominees for Election" are being recommended by the Committee on Nominations for election by the state convention.

Names listed in the shaded areas are for **information only**. These members are currently serving and are not subject to action by the convention in the year 2021.

STATE BOARD OF MISSIONS (97 members)

The State Board of Missions is composed of members elected by the Florida Baptist State Convention from within the bounds of each of the six ministry regions. The regional distribution of Board members is to be made on the following basis of church membership as recorded in the annual statistical report for the prior year: (1) One Board member for 1-8,500 church members which shall increase by one for each additional 8,500 church members or portion thereof; (2) Total membership on the Board shall be no more than 99 members and no less than 90; (3) No ministry region may be permitted more than 22 elected Board members; (4) Each cooperating association shall be represented by a minimum of one member from one of its cooperating churches; (5) No association may be permitted more than five Board members; (6) At least one elected Board member shall come from a church affiliated with the FBSC as a Church-at-Large; (7) In no instance will more than six elected Board members come from churches affiliated with the FBSC as a Church-at-Large, with no more than two Church-at-Large representatives coming from any one of the six ministry regions.



13 Salvations During Holmes County Association's "Evangelism Reboot"

BONIFAY-After noticing a decline in baptisms during the past five years, Holmes Baptist Association hosted an "Evangelism Reboot" weekend to help church members refocus on the importance of sharing the Gospel. At the conclusion of the weekend, 13 new believers were added to the Kingdom.

Kent Lampp, associational mission strategist, referenced the Florida Baptist Convention's 2025 Challenge, with evangelistic goals set by executive director-treasurer Tommy Green, as further motivation for the event. "We decided if we were to do our part in reaching the lost and discipling followers to attain the goal set.... we needed to get busy in preparing and doing what the Lord said He came to do. Seek the lost."

Because the association's 15 churches straddle two sides of the Choctawhatchee River, Evangelism Reboot events were held on both sides of the river at three locations—First Baptist Church in Esto, First Baptist Church in Ponce De Leon and First Baptist Church in Bonifay.

Throughout the weekend nearly 90 adults and 40 students attended three sessions to learn how to share their faith more effectively. Florida evangelist David Burton led the adult trainings and one for the students as well.

"We determined we needed to train some and refresh others on what they already knew and then challenge them to be obedient to the Lord's command," said Lampp.

The event kicked off on Thursday for churches located on the east side of the river; and Friday for those on the west, with a light meal and then the first session of evangelism training.

"At the conclusion of the two hours of training there was an invitation," said Burton, "And one lady gave her heart to Jesus stating she could not remember a particular place or time when she had repented and ask Jesus into her life," he said.

"Now think about this—a church member coming to training in how to share her faith and yet she had never met Jesus. She has now!"

On Saturday, the evangelism rally began with breakfast at First Bonifay, where those who were unable to attend the first training were prepared. Those who attended the previous training devoted their morning to prayer and repentance, asking for God's help in being obedient in sharing.



Middle and high school students gathered from multiple churches on Friday and Saturday while the adults were meeting. Throughout the weekend, various leaders led sessions for the teens.

Halston Brooks, pastor of Ebenezer Baptist Church in Laurel Hill, spoke about creation and imago dei—Latin for "Image of God." Nate Castaneda, youth pastor at West Pittman Baptist Church in Westville, led a session about sin and why salvation was needed. Noah Wagner, youth pastor at First Bonifay, taught the Three Circles Gospel presentation, as a practical and easy method for students to share their faith.

Burton also led training for the students. He equipped them with practical ways to share their faith with family and friends and armed them with knowledge about sharing the Gospel. He asserted their legal rights to evangelize on school campuses.

As a result of the emphasis on evangelism, 12 teens came to realize their deep need for Christ and responded in faith, giving their lives to the Lord.

Since the Reboot, Noah Wagner said he has "witnessed a Gospel boldness" among the students in their schools—"living out their faith, having spiritual conversations, inviting others to come to church."

The weekend concluded with a church commitment time, where churches identified salvation and baptism goals and then shared a fellowship meal.

"It was a fascinating four days," Burton said. "One of the best associational strategies I've participated in," referencing his 25 years on staff at the Florida Baptist Convention and ministry.

A Gang Leader Redeemed, A Family Radically Transformed

HOMESTEAD — The first time Ari Espinoza read a Bible he sat in a dark and lonely prison cell.

For the young Espinoza, being in prison was not unusual. Since the age of five, he had been exposed to gang life through his father's illegal rooster fighting business. The wrong crowd, an impressionable young mind and a lack of a proper role model led the teen down the wrong path.

Today, Espinoza's story is one of redemption. Now the dedicated Christian is a member at the Summit Church in Homestead—the city he calls home— along with his wife and six children. He serves the church in various capacities and has led five of his children and his son-in-law to faith in Christ and more recently, to be baptized.

His life is a story of how God can radically change the life of anyone who puts their trust in Him.

"God can save anybody," said Summit pastor Alex Pecina. "And not just save them but keep them...this man has been radically transformed by the Holy Spirit."

Running with gangs involves stealing, selling illegal substances, money laundering and turf wars among other vices. Loyalty is expected and leaving that life brings fear of reprisal.

The first time Espinoza heard about Christ was when he was assigned to assist the prison chaplain during one of his prison stints. It was not a job assignment he wanted, but it was preferable to solitary confinement.

"I had never been in a chapel before prison because I hadn't ever been to church," recalled Espinoza. "There were six services in the chapel, and I had to clean up after all of them. But I was only required to attend the service led by the chaplain in case he needed me to assist him with anything during the service."

The young man was raised in the Santeria cult, which is grounded in African beliefs and widely practiced in Cuba. "I'm sitting in these services listening to the word of God and I'm going 'wow this is completely different from what I know," he said. "We have to go through the saints, feed the saints, worship the saints and sacrifice to the saints."

Yet when he "called my grandmother to tell her about getting saved, she told me she had been praying that I would come to know the truth."



Still, at this point he had not yet held a Bible in his own hands or read it on his own, he said. Nor did he fully understand what being a disciple of Jesus meant.

Shortly after hearing of Christ during chapel, Espinoza was released from prison. It was short-lived as he violated his parole and was sent back behind bars.

"To survive in prison, you have to be the worst of the worst," he said. He spent most of his time in solitary confinement due to bad behavior. His only companions were his nightmares and a Bible.

"The only thing I had to read was the Bible and even though I didn't understand anything, I read it and God later revealed to me what it meant." And by later, he meant very much later.

Espinoza was eventually released but continued to engage in illegal activities. It was all he knew, but no longer found pleasure in it. He felt a tugging at his heart to change his ways.

"Twenty years after I heard about Jesus in prison for the first time [at age 19], I was sitting at one of my businesses and I said, 'I'm through.' I went home and talked to my wife, and everything changed in our lives."

"I called everybody that I had offended in my life and told them I had come to faith in Christ," he said.

"But when I said 'no' to the world and 'yes' to Christ, no one believed me. They thought I was running a game, that I didn't want to do business with them anymore. They thought I was using God as an excuse to keep them out of something bigger."

Upon exiting the gang life he had known since the age of five, Espinoza and his family lost everything. Dollar stores and jewelry stores used to cover illegal activities were bankrupted. His life was in danger from corrupt business associates. For six years, the family struggled financially.

Uber became a full-time job for both Espinoza and his wife, Barbara. It allowed them to pay bills and feed their children but not much else. On one of her routes, Espinoza's wife picked up a passenger who invited her to Summit Church.

"We start going and the first day, Pastor Alex welcomes us, and I introduce my family. It's amazing what God has done."

"We once lived in fear of what could happen to me if I continued living that kind of life," he said. "I prayed that God would not let my sons be like me. They once looked to me as their protector but now they look to God as their protection and to Jesus as their savior."

"Seeing their faith grow has made my faith grow stronger."

In the past two years, life has settled down for the Espinoza family. His wife teaches school, and he owns a car parts business.

Today, Espinoza visits the buildings where he was once held prisoner by his crimes and by his sin. He shares with the young people who are now trapped there how God can radically change their lives and find the hope he has found in Christ.
