New Home Baptist Church(NHBC) of Perry Florida is a Mission Minded, Southern Baptist, New Testament, Evangelical Body of Believers, located in the Big Bend area of the Florida Pan Handle just east of the Florida State Capital in Tallahassee. We use the King James Bible in our corporate studies, and we align to the Baptist Faith and Message 2000.

We are a Pastor Lead, Deacon Served Body of Believers engaged in regular Church Services, including Sunday School, Children's Church, Lamplighters, Youth Ministry, and Senior Adults. Our members serve the local community through Men's Brotherhood Ministry, Women's Mission Union(WMU), Florida Baptist Disaster Relief and other Missions through the Taylor Baptist Association and Florida Baptist Corporative Program with special focus on the Fellowship of Christian Athletes.

Our Church list 380 members with 110 regularly attending Sunday Services (Morning and Evening) and 70 regularly attending Sunday School. We also hold mid-week services which include a family meal before youth program and adult prayer meeting. Our 2022 VBS Program participation was 85 youth and adults. Our Church has recognized a decline in membership and attendance, we do have church members serving multiple support roles; however, moral of the Church Family remains high as evidence by church member support of the recent VBS program.

New Home Baptist Church was established on October 5th, 1941, through a gift of a family who provided the property and built a wooden structure for worship other buildings were built and used as the Church grew until a new sanctuary was built in 1962 with Family Life Center built in 1985. Additional Facilities include Sunday School Classrooms, Fellowship Hall/kitchen, and two outbuildings and open grounds where Church events are held. Our Family Life center host our Good Shepard Pre-School and Church Administrative offices.

Perry is a city in Taylor County, Florida, United States. As of 2010, the population recorded by the U.S. Census Bureau is 7,017. It is the county seat. The city was named for Madison Perry, fourth Governor of the State of Florida and a Confederate colonel during the American Civil War.

Taylor County was created in 1856 out of Madison County and named after the twelfth President of the United States of America, Zachary Taylor. The county is approximately 982 square miles or 628,320 acres in area. There are 27,037 residents in Taylor County, based on the 2020 census, with a median age of 47.9. The county host the annual Florida Forest Festival and has been long known as the “Tree Capital of the South” since a 1965 designation from then Governor W. Haydon Burns.

At the Tree Capital of the South, many of our residents are employed by the forestry, lumber, and paper industries active in the area. Perry and Taylor County have both public and private educational facilities for early and primary students and is home to Big Bend Technical College. There are also many restaurants, businesses, and shops which make up the local economy.

Spanning over 1,200 square miles, the county is nestled in the “Big Bend” area of the state and offers some of the best hunting and fishing in the state of Florida. Having one of the longest coastlines in the state Taylor County offers some of the best saltwater fishing also with fishing tournaments being held each year.
