Standing Rules

Florida Baptist State Convention

Messengers are advised that the procedural rules that will govern the business sessions of the annual meeting are defined by the Bylaws, Florida Baptist State Convention, specifically Bylaw 1, titled "Rules of Order." The highlights of those procedural rules are as follows:

- **A. Rules of Order:** The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the State Convention in all cases to which they are applicable and in which they are not inconsistent with the Bylaws of the Florida Baptist State Convention and these standing rules.
- **B. Standing Rules:** The Committee on Order of Business shall act as the Committee on Standing Rules in presenting any standing rules (parliamentary and nonparliamentary procedural rules) for consideration by the State Convention during the first session of the State Convention meeting.
- (1) The Committee on Order of Business, at the time it presents the program for adoption, shall call to the attention of messengers present, the existence of the following permanent rules that shall govern the conduct of business during the State Convention meeting:
- (a) For admission to the assembly hall, under certain conditions and at the discretionary order of the State Convention president, to facilitate identification and seating, messengers, visitors, and others may be required to wear the badge issued by the Registration and/or the Credentials Committees.
- (b) A resolution offered by an individual messenger(s) shall be in writing, signed by the maker who shall be a registered messenger to the State Convention, and shall be delivered directly to the desk of the Recording Secretary, after the resolution has been introduced. The introduction of a resolution shall be limited to only the title and/or topic of the proposed resolution being presented, with neither further explanation nor discussion. (See Guidelines for Handling a Motion of Resolution.)
- (c) No messenger shall speak in debate more than twice on the same question during the same session, for no longer than three minutes each time, without the permission of State Convention messengers who may grant such a privilege by a two-thirds vote without debate.
- (d) All reports and other material for the permanent record or printed proceedings shall be in typewritten form and, immediately on presentation, shall be delivered to the Recording Secretary.
- (e) Nominations for each elected office to be filled by the State Convention shall be limited to one nominating speech of three minutes for each nominee. Nominees for any elected State Convention office shall be: a registered messenger; shall have agreed to be nominated; and shall be present on the platform at the time in which they are nominated.
- (f) When more than one candidate is nominated for any convention office, a written ballot shall be taken from all registered messengers present and voting. The Teller's Committee, appointed by the State Convention President, shall collect the ballots, count the ballots, verify and certify the voting results. The chairman of the Teller's Committee shall provide to the State Convention President, on a timely basis as soon as is practicable after the respective vote, a written report on voting results. The report shall include the actual number of ballots cast, the number of votes received by each candidate, and the number of invalid ballots collected.

(2) All motions, resolutions and memorials, except those proposed by the State Board of Missions or by standing committees, and all recommendations made in reports of officers or committees of the State Convention, shall be referred to the Committee on Order of Business. The Committee shall determine appropriate disposition of these motions, resolutions and memorials. Motions of resolutions and recommendations proposed by the State Board of Missions or by State Convention Committees shall be presented by the Board or proposing committee directly to the State Convention, at a time designated by the Committee on Order of Business.

Guidelines

for Handling a Motion of Resolution

On November 13, 2000, the Administrative Committee of the State Board of Missions approved the following procedures for handling a motion of resolution.

- 1. During the first Miscellaneous Business session, a person introduces his/her motion or resolution by stating the subject. The presiding officer will seek to clarify, if necessary, the intent of the motion/resolution.
- 2. A written copy of the motion will be brought to the Recording Secretary's desk located at the front edge of the platform.
- 3. The Committee on Order of Business will set the time for discussion of the motion or resolution. If there is no other miscellaneous business scheduled, the committee could recommend consideration at the time the motion is made.
- 4. The time for discussion of particular motions/resolutions will be announced by the presiding officer.
- 5. At the appointed time set by the Committee on Order of Business, the maker of the motion will be permitted to speak to his/her motion/resolution. As a motion/resolution it will be considered by the Convention body, which may choose to debate, amend, table, refer, approve or defeat the recommendation.
- 6. The presiding officer, in consultation with the parliamentarian, will determine if a motion can be acted upon immediately, rule the motion out of order, or refer it to the Committee on Order of Business.

Connecting Military Families With The Family Of Christ

Relocating with the military can be a stressful time for men, women and children as they navigate a new community, find a home and make friends. The military ministry at Olive Baptist Church in Pensacola seeks to connect with members of the military, encouraging them in Christ.

Naval Air Station Pensacola, known as the home of the Blue Angels, typically employs more than 15,000 military personnel each year. Some arrive in Pensacola as newly enlisted members, and others take part in Naval and Marine Aviation or technical training.

Seeing the need for members of the military to have a family-like connection and a home away from home, Olive began the ministry more than 30 years ago. Whether stationed in Pensacola for three months or three years, military members are often far from their own families and need to be heard, understood and encouraged.

Mike Dimick, military minister and United States Air Force retiree, shared, "It's an opportunity to meet the physical and spiritual needs and to be the hands and feet of Christ as our military men and women face deployment and changes of duty stations. We offer support for their spouses and children as well."

The children of military families can be challenged with leaving friends and getting reestablished in states or even countries far away.

Through connections with other chaplains and churches around the globe, Dimick is able to welcome in and send off military members with contacts, helping them connect in a local church wherever they may be heading.

For those at NAS or Corry Station, a shuttle provides transportation to and from Olive Baptist Warrington campus on Sunday mornings and Wednesday evenings.

Darlene Vannigan, head chef at the Warrington campus, and her staff, provide lunch every Sunday, free of charge, for active and reserve members of the military.


The lunch is often a continuation of senior pastor, Ted Traylor's sermon, as Dimick asks attendees to share something they heard in the message that touched their hearts.

Dimick noted, "The military lunch environment creates a perfect setting for members to share stories about their lives, spiritual walks and military training and experience. I believe some of our greatest growth in the church stems from these meals, as many decisions of salvation and baptism have occurred over breaking bread together."

The military men and women enjoy helping with various church ministries and are always ready to jump in and serve.

"Our military members know they are loved, respected and feel highly valued for the contributions they make in the community, city, country and world for Christ," said Dimick.

Other events are hosted throughout the year, including date nights, when church volunteers provide childcare, giving military parents a night out. Dimick and his wife and ministry partner of 50 years. Maria, attend



The Dimicks hold the ministry close in heart and home with a guesthouse on their property that they use to host military members who need relaxation and recovery or parents and family members visiting for graduations and other occasions. The Dimicks also rent out the guesthouse with portions of the fees going back into ministry for young military families and veterans suffering with PTSD.

The Winston Guesthouse is named after a church member who showed up with a truckload of lumber after hearing Dimick's vision for the space and asked, "Are you ready to start building?"

Dimick recently spent a month in Ukraine on the frontlines with The Warrior's Journey and Reboot Recovery, two organizations that support military personnel who have experienced trauma. "I worked with many who were dealing with refugees and combat trauma in many degrees," stated Dimick. "I was privileged to come alongside and learn, and look forward to starting a Reboot program for those experiencing combat trauma and first responders in our church soon."



UF Students Spend Spring Break On Mission In South Sudan

South Sudan in East Africa is not your typical spring break destination for today's college students, but when the opportunity arose to go there on a mission trip, Emma Formet was all in.

So were Parker Boss and Kristian Kolehmainen. All three college students are members of the University of Florida's Baptist Collegiate Ministries in Gainesville.

On this trip they would be working with Empower One, an organization that "empowers local leaders in the hard places of Africa to establish churches among the unreached and under-engaged peoples." On this trip the team would accompany Empower One Director Chad Vandiver to accomplish three tasks:

- 1. Casting a vision for what a future trip would look like for a full BCM student team during the summer.
- 2. Supporting current long-term missionaries with evangelizing.
- 3. Helping facilitate a discipleship conference.

It was in January when the three learned of this trip and answered God's call to go during their spring break in March. Without a lot of time for fundraising, they had to get busy.

"In two weeks, I made about 75 calls and sent out 150 letters. I got on this as quickly as I could," Formet said. "We each raised the \$4,000 before we left in March. It was really cool to see how the Lord worked out the timing."

Of course, when you share that you're going to South Sudan – one of the most impoverished nations in the world – on a mission trip for spring break, it can catch some of your fellow college students off guard, like it did for these three. Some people wondered how dangerous it might be.

"I was aware of safety concerns, but I was not letting that keep me in a spirit of fear," Kolehmainen said. "A young couple, both missionaries from Florida, just had their first kid and are living there. If it's safe enough for them, I figured it was safe enough for us. Overall, I felt safe the whole trip, but I was on my toes the whole time, aware that something could happen."

Formet said talking about the trip beforehand with classmates gave her opportunities to share her faith.

"It was an incredible evangelistic tool," she said. "I would tell them about the purpose of our trip in sharing the gospel and making known the name of Jesus. Like in my Organic Chemistry 2 lab, I got to share the gospel with a whole group of students while we were waiting for one of our reactions to finish. It was so cool."

Door-to-door evangelizing

For the first half of the trip, the team worked with missionaries in the capital city of Juba to do door-to-door



"It was just amazing," Boss said. "All the people we reached out to on Saturday were in church on Sunday morning, and it was just wonderful to see the Lord was already at work in hearts and lives there, and we just came alongside and got to see that."

Since South Sudan was originally settled by England, many people there speak English, which made it easy for the team to talk with local residents. Others spoke Arabic, and the team had interpreters to help with translations.

Kolehmainen said he loved seeing how the people were so open and receptive to the gospel. "It's a huge contrast to here in America where most people are aware of Christianity but choose to reject it or not seek it. There, people have already accepted that Christianity is true, but they didn't know how to pursue it"

6. 2022 Maguire State Mission Offering Report

The 2022 Maguire State Mission Offering was directed by the State Board of Missions toward the Send Network Florida Initiative. By utilizing the state mission offering to create an additional funding source for church planting, it allows every Florida Baptist church contributing to the Maguire State Mission Offering to be a supporting church of the Send Network Florida church planting partnership between the Florida Baptist Convention and the North American Mission Board.

With the close of the Convention's accounting year on December 31, 2022, a total of \$939,238 was received for the year 2022 Maguire State Mission Offering. The 2022 total represented 114 percent of the offering goal of \$820,000. The total number of churches contributing to the offering increased to 504 from the 502 participating the prior year. Additionally, the Challenge 2025 initiative that Dr. Green has outlined for the Florida Baptist Convention sets an annual Maguire State Mission Offering goal of \$1,000,000 by the year 2025. We are encouraged by the continued growth in the annual offering as we reach towards this goal.

7. 2022 Maguire State Mission Offering

On March 31, 2023, the State Board of Missions approved a 2023 Maguire State Mission Offering goal of \$880,000 and again directed 100 percent of the offering be allocated to the Send Network Florida church planting initiative.

21. Appointment of Investment Subcommittee

The Finance Committee of the State Board of Missions has fiduciary responsibilities related to endowment funds, special funds and undesignated investment funds held by the Florida Baptist Convention. The Committee's responsibilities are defined in the Bylaws of the State Board of Missions. To facilitate this requirement, each year the chairman of the Finance Committee appoints an Investment Subcommittee selected from the membership of the Finance Committee. The chairman of the Finance Committee appointed the following persons to serve on the Investment Subcommittee for the year 2023:

The Investment Subcommittee met quarterly during the year and provided reports to the State Board of Missions at their March and August meetings.

22. Setting Spending Rate for Cooperative Program Endowment Fund

On March 31, 2023, the State Board of Missions approved setting a spending rate for 2023 of four percent of the December 31, 2022, balance of the Cooperative Program Endowment Fund. A draw from the endowment fund in the amount of \$168,000 was completed in June 2023 and deposited into the Cooperative Program budget.

23. Allocation of 2022 Florida Baptist Convention Cooperative Program Budget Net Cash Surplus

During a meeting of the State Board of Missions on January 26, 2023, the board authorized the transfer of \$640,000 in funds related to 2022 Florida Baptist Convention Cooperative Program Budget Net Cash Surplus Funds from the Operating Reserves designated for the following:

24. Florida Baptist Convention Board-Elected Personnel Changes

Effective March 31, 2023, **Craig Culbreth** retired as Regional Catalyst, East Region, a position he held since 2017.

Patrick D. Coats vacated his position as Black Multicultural Catalyst, a position he held since 2017, and was elected by the board on March 31, 2023, to transition to the position Regional Catalyst, East Region effective April 1, 2023.

Effective March 31, 2023, the board approved a change of title for Haitian Church Catalyst to Haitian Multicultural Catalyst.

Effective March 31, 2023, the board approved a change of title for Hispanic Church Catalyst to Hispanic Multicultural Catalyst.

Effective March 31, 2023, the Black Multicultural Church Catalyst position transitioned from a board elected position to a contract position.

Effective June 30, 2023, **Gary Townsend** retired as Regional Catalyst, North Region, a position he held since 2017.

Effective June 1, 2023, and prior to the retirement of Gary Townsend, **J. Phillip Herrington** was elected to the position of Regional Catalyst, North Region. Prior to accepting the position, he served as Senior Pastor at First Baptist Church, Live Oak.

Effective August 25, 2023, the board approved a change of title for Director, Information Support Services to Director of Technology Services. This position also moved under the supervision of the Strategic Initiatives Group.

During the year the following individuals were appointed to consultant/contract ministry positions:

25. Florida Baptist Historical Society: Appointment of Board of Directors

The Governing Document of the Florida Baptist Historical Society provides that a full term shall be three years and that a "board member shall be eligible to serve two full terms of three years each." One former board member – Dr. Don Minshew – would have completed his first three-year term at the end of 2023. However, Dr. Minshew resigned from service in December 2022 when he retired from his employment with the Gulf Stream Baptist Association and moved out of state. During its meeting on August 25, 2023, the State Board of Missions elected Dr. Maxie Miller of Plant City to the Historical Society Board for the term from January 1, 2024 to December 31, 2026 previously held by Dr. Don Minshew.

Additionally, during its meeting on August 25, 2023, the State Board of Missions approved the appointment of Dr. Mark Rathel to fill one of the "permanent" positions designated for the Curator, the Baptist Archives, on the Florida Baptist Historical Society Board of Directors, effective immediately to serve an open-ended term of service until the administration of The Baptist College of Florida designates an individual as the curator of the Baptist Archives.

26. Recommendation to Adjust Florida Baptist State Convention Annual Meeting Location Schedule

During the August 2023 meeting, the board evaluated opportunities for moving the host location of the annual meeting of the State Convention to Central Florida on an ongoing basis. The board is recommending to messengers during the November 13-14, 2023, meeting in Lutz to approve a change in the meeting location for the years 2024, 2025 and 2026. First Baptist Church of Orlando has graciously agreed to host the 2024, 2025, and 2026 annual meetings of the Florida Baptist State Convention for this pilot project. If successful, messengers will be asked in future years to permanently modify the state convention's bylaws related to this change.

27. Establishment of an Affiliate Relationship with the Evangelical Council for Abuse Prevention

During the March 2023 meeting of the State Board of Missions, the board approved an affiliate relationship between the Florida Baptist Convention and the Evangelical Council for Abuse Prevention for the primary purpose of training/resourcing Florida Baptist churches in the areas of child protection, and response.

28. Financial Fraud Incident

On May 8, 2023, the Administrative Committee of the State Board of Missions was notified about a financial fraud incident that occurred through cybertargeting. A subcommittee was formed and was tasked with providing oversight and recommending the next steps regarding the investigation. Members of the subcommittee were Aaron Burgner, Darren Gaddis, Paul Purvis, Brian Stowe and Angel Turbeville. The full board was notified of the situation via email on May 9, 2023 and an update was provided to the entire board via videoconference on May 17, 2023. At the August 2023 meeting of the board, the subcommittee shared a final report. This report outlined the timeline of events and actions taken by the subcommittee to fully investigate the incident. The subcommittee worked with federal and state investigators, internal and external auditors and cyber forensics experts in their investigation into the more than \$700,000 in funds stolen from the convention through cybertargeting.

The investigation revealed no criminal activity on the part of any Florida Baptist Convention staff person but instead concluded that the crime was the result of sophisticated cybertargeting by, at this point, unknown perpetrators. The subcommittee's work culminated in the recommendation for strengthened financial protocols and ongoing training for convention staff. The convention is additionally exercising heightened awareness when carrying out financial duties and implemented additional data security controls.

29. Evangelical Council for Financial Accountability Accreditation

In response to the financial fraud incident and in an effort to increase financial accountability, during the August 2023 meeting of the State Board of Missions, the board learned the Florida Baptist Convention was pursuing accreditation through the Evangelical Council for Financial Accountability. The convention is currently

completing the process and is expected to achieve accreditation status by the end of Q4 2023.

30. Regional Pastors' Wives Support Networks

During the August 2023 meeting, the board received a recommendation from convention staff regarding establishing a Regional Pastors' Wives Support Network in an effort to continue being 'right beside' local churches and pastors' families. The Southwest Region will be the first region to launch this fall, and it is expected that other regions will launch after the first of the year. The board authorized the executive-director treasurer to utilize available budget and non-budget funds to support this new initiative, with the expectation that in future years, budget allocations specific to this ministry will likely be necessary.

31. Action Regarding Florida Legislature Senate Bill 1718 and House Bill 1617

During the March 2023 meeting, the board reviewed information regarding Florida Legislature Senate Bill 1718 and House Bill 1617 which sought to reform the state's immigration laws. Additionally, the board learned that convention staff had engaged in the legislative process, along with evangelical partners, to highlight the concerning limitations the proposed bills would place on churches seeking to carryout compassion ministries in their communities. Thankfully, these concerns were noted by government officials and final legislative action did not impact the historic work of the church.

32. Sanctity of Life

The board has continued to take action on behalf of Florida Baptists to protect the sanctity of all human life. In March, the board approved joining an Amicus Brief with the Florida Conference of Catholic Bishops. This brief was filed with the Florida Supreme Court in response to a pending case in which proponents of abortion were seeking to overturn the 15-week heartbeat bill that was passed by the Florida Legislature and signed into law by the Florida Governor. The Supreme Court heard oral arguments in early September and, as of the printing of this report, had not returned a decision.

33. Resolution Concerning the Decisions by the Southern Baptist Convention's Executive Committee and the Abuse Reform Implementation Task Force to Retain Guidepost Solutions

In response to growing concerns of Florida Baptist pastors and churches regarding the decisions of the Southern Baptist Convention Executive Committee (SBC EC) and Abuse Reform Implementation Task Force (ARITF) to engage Guidepost Solutions, the board adopted a resolution on behalf of the Florida Baptist State Convention that spoke strongly to this concern, up to and including potentially escrowing the portion of Cooperative Program funds allocated for the SBC Executive Committee. This resolution would further empower the messengers to make decisions at the November 2023 annual meeting if necessary. Thankfully, decisions at the national level by both the SBC EC and ARITF have been to move away from Guidepost Solutions.

34. Commence Legal Action to Protect Church Property

During a special-called meeting of the Administrative Committee on September 26, 2022, committee members were briefed on an ongoing issue regarding the church property of the former First Baptist Church of Lake Rousseau. The church membership had voted to disband the church, and the property's future was at stake. The Florida Baptist Convention was named in the property deed with a reversionary interest. Throughout the past year, the convention's

outside legal counsel, on behalf of the board, has proceeded with various actions attempting to protect the property for continued Baptist work. We pray that the convention will be successful in the coming months and that the property will be repurposed for a new church plant.

35. Revise State Board of Missions Bylaws 2, 3 and 4

The long-standing pattern for many of the governing documents for the Florida Baptist State Convention and the State Board of Missions has been to repeat information in multiple places – often duplicating verbatim the same instructions.

One such instance occurs regarding the membership of the State Board of Missions. At the 2018 annual meeting of the Florida Baptist State Convention, messengers adopted revisions to the Florida Baptist State Convention Bylaws that govern the work of the Committee on Nominations and that specifically outlined the membership process and makeup of the State Board of Missions (Bylaw 12 Florida Baptist State Convention).

The membership and organization of the board is also delineated in State Board of Missions Bylaws 2, 3 and 4. The plan in 2018 was to amend the state convention's bylaws and, if the new methodology proved successful, then update the State Board of Missions Bylaws at a subsequent annual meeting. The board believes more than enough time has passed, the new process is functioning well, and it is appropriate to revise the board's bylaws now. The board will recommend revisions to these bylaws during the 2023 annual meeting in Lutz, Florida.

36. Letter to the SBC Credentials Committee regarding Freedom Church

During its March 2023 meeting, the board authorized the release of a letter to the SBC Credentials Committee regarding the convention's actions to disfellowship Freedom Church of Vero Beach in 2022. This action was taken in response to the Credentials Committee request for information about the state convention's decision.

Authorization of the Retention of Batts, Morrison, Wales and Lee, P. A. as the Auditor-of-Record for the Florida Baptist Convention, Inc.

During the August 2023 meeting, the board approved the retention of the auditing services of Batts, Morrison, Wales and Lee, P.A. of Orlando, Florida for the years 2023, 2024 and 2025.

38. Florida Baptist Day of Emphasis and Special Offering for the Baptist University of Florida

During the August 2023 meeting, the board approved the following:

- That the last Sunday of each January be established in Florida Baptist life as a day of special emphasis and prayer for the Baptist University of Florida- with the first day of recognition being Sunday, January 28, 2024; and
- That the Baptist University of Florida be authorized to promote a special offering in the month of January that culminates with the special emphasis day.

39. Update to Employment Handbook of the Florida Baptist Convention

During the March 2023 meeting, the Administrative Committee reviewed and approved an updated employee handbook for the Florida Baptist Convention.

40. Board Policy Updates

As a part of the regular update of policies of the State Board of Missions, during the March 31, 2023 and August 25, 2023 meetings, the board approved policy additions, revisions and/or replacements for the following policies:

Immigration Surge Inspires Ministry Surge

The waves are surging. As wave upon wave of immigrants enter America, Florida Baptists are catching the wave and sharing God's love with those from international lands who seek to begin new lives in the Sunshine State.

Immigrants from Cuba, Haiti, Central America, Mexico and other places throughout the world are descending upon Florida in what some leaders describe as "the largest surge in migration" ever, and the surge is far from over.

Many individuals arriving in Florida from other countries are asylum-seekers or refugees, who are "fleeing difficult circumstances. They are going through dangerous journeys to get to America," said Emanuel Roque, Florida Baptists' Hispanic church catalyst.

"Once they are here, we love them."

"We are privileged to be in this place that God has called us to as part of His plan. He has been developing and preparing generations of Florida Baptists to reach the Florida mission field."

He described Florida Baptists' role with immigrants as "rescue 911." When the Surfside condominium collapsed in 2021 in a Miami suburb, first responders had no time to rest, he said, as they desperately sought to rescue victims. Likewise, Roque said, Florida Baptists are "first responders" to many of today's immigrants who need immediate ministry. First responders have no time to waste talking, debating or dealing with political ideologies or strategies.

Myles Dowdy, missions and ministry lead catalyst for the Florida Baptist Convention, agreed, "We're not going to get political about immigration. We're going to get spiritual about it. We are going to minister and witness to those coming into our state. We're going to love on them."

Roque has a personal passion for ministry to immigrants. Decades ago, his parents immigrated from Cuba to New York City, where Roque was born. When the young Roque was only a year old, his parents moved the family to Miami, where they helped plant Iglesia Bautista Resurrección in Miami. There, Roque made his profession of faith in Jesus as his Savior and was baptized and discipled.

Through the years, "Florida Baptists have had a heart and clear understanding that we are in a state that is a mission field. Florida Baptist have been there when opportunities arise to help churches share the gospel," Roque said.



As a part of catching the wave of immigrants, Florida Baptists, in partnership with Send Relief, have designated several churches as immigration ministry hubs with specific focus on reaching immigrants with Hispanic or Haitian heritage. These churches have long ministered to immigrants, and their designation as ministry hubs provides additional funding and resources for their outreach efforts. These ministry hub churches also provide resources and training for other Florida Baptist churches wanting to launch or strengthen ministry to immigrants and offer opportunities for more Southern Baptists to become involved in hands-on mission service.

'God's expression of love'

Betesda Baptist Church in Miami, pastored by Frank Rodriquez, is intentionally ministering to immigrants coming their way. For Rodriguez, ministering to refugees and immigrants is personal. In 2012, he immigrated to Florida from Cuba, where he had served as a pastor for more than two decades. Once settled, Rodriguez immediately began planting Betesda in Miami, purchasing property in 2021.

For the past four to five months, the church has housed 17 immigrants in its church building. Otherwise, these individuals would be sleeping on the street, Rodriquez said. "These people have nothing ... nothing," he emphasized.

STATE BOARD OF MISSIONS Recommendations to the Florida Baptist State Convention

Recommendation 1:

2024 Florida Baptist Convention Budget

The State Board of Missions recommends that the Florida Baptist State Convention adopt the year 2024 Cooperative Program Basic Budget of \$29,500,000 based on the following distribution and the general detail as noted in the attached budget document:

(a) That all Cooperative Program income receipts be distributed on the following percentage allocation:

Southern Baptist Convention causes 51.00% Florida Baptist Convention causes 49.00%

(b) And that the Cooperative Program Basic Budget designated for Florida Baptist Convention causes (or 49% of total Cooperative Program income) be distributed on the following basis:

Total Florida Baptist Convention \$14,455,000

Convention Programs of Mission, Ministry, and Support \$12,063,000

Cooperating Ministries\$2,392,000The Baptist College of Florida\$1,320,000Florida Baptist Children's Homes\$912,000Lake Yale Baptist Conference Center\$160,000

(c) That all Cooperative Program receipts received by December 31, 2024, and which are in excess of the budgetary requirements specified within the 2024 Cooperative Program budget shall be designated as Cooperative Program Excess Budget funds.

Additionally, we direct 51% of such excess funds be immediately distributed to the Cooperative Program of the Southern Baptist Convention. Further recommendations and subsequent board action on the distribution of the remaining 49% of Excess Budget funds shall be in keeping with the State Convention's Business and Financial Plan [Bylaw 16, B (3)(a)(b), Bylaws of the Florida Baptist State Convention].

(d) Furthermore, the convention recognizes the autonomy of each local church and the decisions that each may make regarding cooperative giving to Southern Baptist Convention causes. As such, the convention will appropriate gifts to cooperative causes as directed in writing by a local church.

Florida Baptist State Convention Constitution Articles 11. 13 and 14

Article 11. The annual meeting of this State Convention shall typically be held during the month of November at such time and place as the State Convention may elect. As set forth in more detail in Bylaws 11 & 12 of the State Convention's Bylaws, the State Board of Missions may change the meeting place and/or time, including the month, of the annual meeting of the State Convention in any given year as necessary and/or desired.

Article 13. The Annual Meeting of this State Convention—barring a catastrophic event or other wide-spread emergency—shall be held each year. Its primary purposes, with time allocated in a priority sequence to ensure the general and specific objectives of the State Convention (as defined in Article 3 of this Constitution), are as follows:

- A. To conduct the business and consider the needs, problems and opportunities of the State Convention and its cooperating ministries;
- B.To permit the State Convention's *cooperating ministries* to report on their prior year's activities and to make appropriate recommendations for consideration by the messengers comprising the annual meeting;
- C.To ensure time is allocated on the annual program for the several requirements *specified* by the State Convention's Bylaws;
- D.To elect State Convention officers and to elect persons to fill vacancies on the State Convention's committees and boards as defined in Article 9 of this Constitution;
- E.To hear messages from the State Convention president and the person designated to bring the Convention Sermon; and
- F. When practicable and within the available remaining time, provide appropriate inspirational emphases and/or special emphases to be determined by the program committee (also known as the Committee on Order of Business) as defined in the State Convention's Bylaws.

Article 14. This Constitution or any article thereof may be amended by the affirmative vote of two-thirds of the messengers

present and voting at a meeting at which a quorum is present, at two (2) successive annual sessions of the State Convention. Notice of any change proposed must be published online by the Florida Baptist Witness and shared on one or more of the Convention's social media platforms at least thirty days prior to the annual meeting of the State Convention.

Recommendation 6: Constitution Revision-Revise Article 10, Constitution, Florida Baptist Convention changing the name of Florida Baptist Children's Homes, Inc. to One More Child

The State Board of Missions recommends that the messengers to the Florida Baptist State Convention, adopt the following:

State Board of Missions Bylaws

Bylaw 2: Board of Directors

A. Definition

The State Board of Missions functions as the board of directors of the Florida Baptist Convention, Inc., a Not-for-Profit Corporation. The affairs of the Corporation are managed and directed under the authority of this board. Persons who serve on the State Board of Missions are elected and governed by the provisions set forth in the State Convention's Constitution and Bylaws, amended and approved by the duly elected messengers attending the annual meeting of the Florida Baptist State Convention, an unincorporated association of cooperating Baptist churches in the State of Florida.

B. Members, Term of Office & Manner of Election

The members of the State Board of Missions will be made up of those individuals selected in accordance with the process set forth in Bylaw 13 of the Florida Baptist State Convention. Such individuals shall be elected in the manner (and serve the duration of office) set forth in Sections B & C of Bylaw 13.

Bylaw 3: Other Provisions Established by the State Convention

A. Organization, Committee Structure and Special Works

The State Board of Missions will be organized in the manner set forth in Bylaw 13 of the Florida Baptist State Convention. Such organization shall include the committee structure delineated in Section F therein. As authorized in Bylaw 13, the State Board of Missions shall be empowered to carry out its right and necessary duties as the Board of Directors. Such duties include the "special works" set forth in section G of Bylaw 13.

B. Conflicts of Interest

The State Board of Missions shall adopt and adhere to a "Conflicts of Interest" policy statement and procedures that shall govern the conduct of board members and employees of the Florida Baptist Convention, Inc. This policy shall emphasize the fiduciary duty and responsibilities these persons have to exercise their best care, skill and judgment for the sole benefit of the Convention. Each board member shall be required to annually complete, sign and submit a board-approved questionnaire on "Conflicts of Interest."

C. Quorum

Fifty-one percent of the membership shall constitute a quorum.

Bylaw 4: Officers

As set forth in Bylaw 13 of the State Convention, the officers of this Corporation shall be a President, a Vice-President, a Recording Secretary, a General Secretary, to be known as Executive Director-Treasurer, and an Assistant General Secretary, to be known as Assistant Executive Director.

- A. <u>President</u> The President of the State Board of Missions shall be the President of the Corporation. He shall perform the following duties:
- Preside over all meetings of the Administrative/ Personnel Committee and the State Board of Missions.
- Exercise all powers, duties, and functions incident to the presidency of similar corporations. With the Executive Director-Treasurer or the Assistant Executive Director, execute deeds, mortgages, and contracts relating to the purchase, sale, and encumbrancing of real property.
- 3. Appoint the Nomination of Board Committees Committee, using the other board-elected officers to assist him if he so desires.
- 4. Appoint all special committees deemed necessary and appropriate by the board.
- Serve as an ex officio voting member of all standing and special committees of the board.
- In compliance with requirements by the Convention Corporation's auditor-of-record, the board President shall on a periodic basis receive, review and sign off on the monthly travel expense reports of the executive director-treasurer.
- B. <u>Vice-President</u> The Vice-President of the State Board of Missions shall be the Vice-President of the Corporation. He shall perform the following duties:
- 1. Assist the President in the performance of his duties.
- In the absence or disability of the President, perform the duties of the President, including the execution of deeds, mortgages, and contracts relating to the purchase, sale and encumbrancing of real property.
- 3. Perform any other duties as requested by the board.
- C. <u>Recording Secretary</u> The Recording Secretary of the State Board of Missions shall perform the following duties:
- 1. Record the minutes of all meetings of the board.
- 2. Perform any other duties as requested by the board.
- D. <u>Executive Director-Treasurer</u> The Executive Director-Treasurer of the Florida Baptist Convention, Inc., shall perform the following duties:
- Supervise and direct the entire mission program of the Convention, being subject at all times, to the direction and control of the State Board of Missions.
- 2. Perform those duties designated by the Corporation as described in Bylaw 3,B(7) of these Bylaws.
- 3. He shall execute with the President or Vice-President of the Corporation, all deeds, mortgages, and contracts relating to the purchase, sale, and encumbrancing of real property. He shall execute, in the name of the Corporation, partial releases and satisfactions of mortgages, subordination and subrogation agreements, conditional release agreements or reverter and reversion clauses contained in deeds or other documents for the life of any mortgage, trust indenture or bond, and shall affix or place the corporate seal upon all legal papers which require same.
- Maintain complete and permanent records and accounts, and shall be the custodian of all property, books, papers, records, insurance policies, bonds,

- and other effects belonging to the Florida Baptist Convention, Inc., or pertaining to the work and affairs of the Florida Baptist Convention, Inc., the board and the corporate body.
- Upon leaving the office, deliver to his successor or such person as the board shall designate all property, books, papers, records, insurance policies, bonds, and effects of the Florida Baptist Convention, the board and the Corporation.
- Issue all notices for meetings of the board or State Convention.
- Perform all such other duties as may be requested by the State Convention or the board.
- E. <u>Assistant Executive Director</u> The Assistant Executive Director of the Florida Baptist Convention shall perform the following duties:
- Assist the Executive Director-Treasurer in the performance of his duties.
- 2. Perform the duties of the Executive Director-Treasurer in the absence or disability of the Executive Director-Treasurer. This task shall include the execution, along with the President or Vice-President, of deeds, mortgages, and contracts relating to the purchase, sale and encumbrancing of real property. He shall execute, in the name of the Corporation, partial releases and satisfactions of mortgages, subordination and subrogation agreements, conditional release agreements or reverter and reversion clauses contained in deeds or other documents for the life of any mortgage, trust indenture or bond, and shall affix or place the corporate seal upon all legal papers which require same.
- Perform all other such duties as shall be assigned to him by the Executive Director-Treasurer and as may be requested by the State Convention or the board.

Florida Baptist Hispanics Share Gospel In New Orleans

Thirty-four Florida Baptist Hispanic pastors and volunteers joined with Hispanic Baptists from throughout the nation to share the gospel in

New Orleans June 9-11.

Their efforts were a part of Crossover, an evangelistic outreach initiative designed to saturate the host city of the Southern **Baptist Convention** annual meeting with the gospel in the days leading up to the SBC gathering.

Pastor Eloy Rodriguez of Idlewild en Español in Tampa took a group of 34 pastors and volunteers from Florida for the event. The group went door

to door evangelizing, feeding and praying with families in communities throughout New Orleans in partnership with local Hispanic churches. The group was divided into several teams that worked a total of six projects in partnership with 13 local churches: La Viña Kenner, La Viña Westwego, Emanuel, Jesucristo para las Naciones, Maranatha, El Buen Pastor, Horeb, Horeb Chalmette, Lugar Seguro, Getsemani, Cristo Redentor, Buenas Nueva and El Camino.

During this year's event, the group served 2,500 meals, shared the gospel with more than 1,000 people and prayed with 100 people who made professions of faith.



Calvary Church Reaches Deaf Community For Christ

For Ron Cooney, a specific church ministry originally brought his family through the doors of Calvary Church when he was 14 years old. As a child of a deaf adult (CODA), Cooney and his family were able to find a home at the Central Florida church. Now, years later, Cooney still calls Calvary Church home—as its executive pastor.

"God used Calvary's Deaf Ministry to bring my entire family to faith in Christ," said Cooney. "We are forever grateful for the kingdom work that has been done in the Deaf Ministry at Calvary through the years. They are an extension of my family."

Most of the approximately 70 million Deaf and Hardof-Hearing people around the world have never seen Jesus's name signed in their language. With a desire to reach this mostly unreached and unengaged mission field, Calvary Church has sought to serve some of the least evangelized people on earth—the Deaf community.

'Our vision for the Deaf Ministry at Calvary is to build relationships to bring the Deaf and Hard of Hearing to dynamic life in Christ locally in order to develop and deploy them to do the same in their communities and around the world.'

"With an understanding that globally, the Deaf and Hard of Hearing are mostly unreached and unengaged, our vision for the Deaf Ministry at Calvary is to build relationships to bring the Deaf and Hard of Hearing to dynamic life in Christ locally in order to develop and deploy them to do the same in their communities and around the world," he said.

Calvary's Deaf and Hard of Hearing Ministry has existed for almost 50 years and continues to serve the Deaf in its community. "The ministry is a huge part of our DNA as a church," Cooney said. "I certainly don't know our church without a Deaf Ministry, and I am certain that if it wasn't for the Deaf Ministry, I would not be at Calvary and may not have even been exposed to the saving power of the gospel."

Through intentional effort, countless interpreters and Christlike volunteers—the church's Deaf Ministry has thrived, giving "Deaf individuals every opportunity a hearing person has in the life of the church," said Cooney.

"From responding to the gospel in an interpreted service on a Sunday morning, membership classes, and Bible studies, to serving on one of our serve teams or as a deacon ... this is only possible because of the dedicated and unselfish care of our interpreters," he shared. "These interpreters embody the call of Romans 12:1-2 and have my deepest respect."

Cooney added, "While Calvary has had an ongoing ministry to families with special needs, we decided to prioritize this further by hiring a staff member to focus on this particular area. This is a new position and a ministry that we hope grows into a vibrant one for families in our community who have various special needs."



Not only are the weekly worship services interpreted for the Deaf, but the church also offers Deaf Bible studies, a "Hands of Praise" choir, camps and many social activities throughout the year.

From Christmas musicals and Vacation Bible School for the Deaf to mission trips—Calvary's Deaf and Hard of Hearing Ministry continues to look for "creative outlets in order to build relationships with the Deaf community in the Tampa Bay area," said Cooney. The church has broadened its reach to the Deaf community by hosting the Southern Baptist Conference for the Deaf, where more than 200 people gathered on the church campus for the recent annual meeting. The church also will be hosting the Florida Baptist Conference for the Deaf in 2024, with hopes of encouraging other churches and ministries to the Deaf to keep pursuing Jesus and the call of discipleship.

The call to pursue Jesus and actively disciple a generation is exactly what Calvary Church desires to do for years to come. "God has used the Deaf Ministry at Calvary to reach families and change lives," he said. "We know that there are many ways to minister to the Deaf, and we constantly seek new ways of engaging the lost community around us, including those who are Deaf."

Cooney described how the church's Deaf and Hard of Hearing Ministry serves the entire body of Christ. "When the church's differences are on display, I believe with all of my heart that the whole is better served," Cooney said. "This comes with its own unique challenges. But if you have godly people who believe the best about each other and who trust one another, you can accomplish the unimaginable. I like to think that we have those people in place at Calvary. As we embrace some of the differences between us—specifically, how we communicate—it has allowed us to see the kingdom difference we are making."

The executive pastor who became a Christian through Calvary Church's Deaf Ministry so many years ago looks forward to the day when all believers together will praise God's name. "One day, when we are all gathered around the throne of grace, one of the 'tongues' that will be used to worship our great God and King will be those doing it in American Sign Language," he said. "As for me, I guess I will use my native language as well as my hands to proclaim, 'Holy, holy, holy is the Lord God Almighty.""

The Committee on Nominations of the Florida Baptist State Convention presents the following report for consideration and action by the Florida Baptist State Convention, November 13-14, 2023.

Persons listed in the sections "Nominees for Election" are being recommended by the Committee on Nominations for election by the state convention.

Names listed in the shaded yellow areas are for information only. These members are currently serving and are not subject to action by the convention in the year 2023.

STATE BOARD OF MISSIONS

The State Board of Missions is composed of members elected by the Florida Baptist State Convention from within the bounds of each of the six ministry regions. The regional distribution of board members is to be made on the following basis of church membership as recorded in the annual statistical report for the prior year: (1) One board member for 1-7,500 church members which shall increase by one for each additional 7,500 church members or portion thereof; (2) Total membership on the board shall be no more than 99 members and no less than 90; (3) No ministry region may be permitted more than 22 elected board members; (4) Each cooperating association shall be represented by a minimum of one member from one of its cooperating churches; (5) No association may be permitted more than five Board members; (6) At least one elected board member shall come from a church affiliated with the FBSC as a Church-at-Large; (7) In no instance will more than six elected board members come from churches affiliated with the FBSC as a Church-at-Large, with no more than two Church-at-Large representatives coming from any one of the six ministry regions.



Brazilian Church Plant In Delray Beach Reaches Haitians With Gospel

One-year-old church plant Brazilian Baptist Church is reaching not only Brazilians in the Delray Beach community, but also Portuguese-speaking Haitian families.

Pastor Marcos Andrade says he did not set out intentionally to reach Haitian families; it all happened by God's guidance.

Andrade is bi-vocational, and when he is not pastoring Brazilian Baptist, he is driving for Uber. During one of his trips, he met a Haitian family that needed to go to the hospital with a sick family member and they asked if he would drive them.

Andrade not only drove them to the hospital but also stayed with the family at the hospital while they waited. As they sat around waiting and talking, Andrade told them he was a pastor and invited them to visit the church. Happy to hear that he was a pastor, they told him that they "loved to go to church."

It wasn't long before the family visited the church, and they stayed. Soon, the family told other Haitian friends about the church, and those friends started attending also. Members of Brazilian Baptist joke that most people attending today were also "just visiting" once but ended up staying permanently.

Haitian Marie Lucie is a mother of three who lived in Brazil for ten years. During that time the family attended church, and her children—the youngest being born in Brazil—practiced their faith in Portuguese. They knew worship songs and read the Bible in Portuguese. Their heart language was Portuguese even if their culture remained Haitian. Lucie says that her children prefer to go to a Portuguese-speaking church even though they speak Creole, English and Spanish.

"When we came here, we missed the warmth and community we experienced while we went to church in Brazil, and we were able to find it here at Brazilian Baptist," she said.

"In South Florida the time has come that churches can no longer afford to focus exclusively on reaching people with the gospel that only look like them or speak their language. People from all ethnic and racial backgrounds live together," said Al Fernandez, southeast regional catalyst for the Florida Baptist Convention.

"The Brazilian Baptist Church of Delray is an example of a new church that is focused on reaching the diaspora and impacting its entire community. I am grateful to God for church planters like Marcos Andrade who are expanding the kingdom of God to all people."



Lucie, like many other Haitians following the 2010 earthquake that rocked Haiti, immigrated to Brazil in search of better opportunities for her and her family. In 2012, as a response to the increase in the number of Haitians claiming asylum in Brazil, the government opened an opportunity for Haitians to regularize their status through humanitarian visas. As of 2020, the Haitian population living in Brazil was estimated to be around 143,000.

In 2021 when unemployment rates and the cost of living in Brazil climbed, Haitians were on the move again, making the perilous trip through the South American forests to the U.S. border.

On a Sunday evening this May, the church met for its Sunday worship service at First Baptist Church of Delray, sending church for the young congregation. Pastor Andrade played an acoustic guitar; a young man played percussion on a box drum, and another one played the piano while the multicultural, multigenerational church sang hymns in Portuguese. The group of about 30 spent time after the service fellowshipping over coffee and cake. There was no separation of groups; no one was left out of the conversation.

"We really are all a family, and God is the One bringing us all together as one," said Andrade. "God is showing me and guiding me to be everyone's pastor, to love them each and minister to each person where they are and as they are."

Handmade Dresses Share God's Love With Little Girls Throughout World

Little girls around the world are smiling and experiencing God's love through handmade dresses sewn by the volunteer women of Sew



Emely Pagan started Sew Culture in 2014 after participating in a sewing workshop in her hometown of Naples.

"I thought I was doing really well because I kept getting switched from stations at the workshop until I ended up in the ironing station. Turns out they put me there because I couldn't sew," she recalled with a laugh. "I don't know how to sew, and yet God has called me to a sewing ministry."

When Pagan learned the women in the workshop were sewing dresses and sending them to little girls in Africa, she felt called to do the same thing for little girls in need in Latin America. There was just the issue of not being able to sew.

Pagan enlisted her sister, the only person she knew who could sew, and together they launched Sew Culture in 2014. Their mission is to bless little girls with something new made just for them. The ministry has grown to 26 volunteers who have sent dresses to many countries in Latin America and to Ukraine, Estonia, Russia and India.

Eight of the volunteers sew, and others decorate, cut fabric, and clean up the workspace. Each dress has the Sew Culture tag and a short message of God's love.

Until September 2022, Sew Culture operated out of a warehouse near the Naples coast. When Hurricane Ian hit the Florida Gulf Coast, the warehouse flooded, and Sew Culture lost almost all of its inventory.

East Naples Baptist Church then graciously offered Sew Culture one of its mission houses to continue its ministry.



Pagan's husband, JR Pagan, is the associate pastor at East Naples. Royal Palm Network/Association of Churches partnered with the ministry to help build back the lost inventory.

Just this March the ministry started a partnership with One More Child. Through the partnership, Sew Culture has committed to sewing 100 dresses every month that One More Child will then send abroad to little girls in need.

"God is opening doors, and I am walking right through them," Pagan said.

Recently, the sewers have started to make shorts for boys. "We want the boys to get something new too. We learned that when the girls were receiving their dresses, the boys would be waiting eagerly for something for them too. We don't want them to be left empty-handed," she said.

Sew Culture is selective about the fabric used because volunteers want the girls and boys to get the best. The ministry uses 100% cotton fabrics for the dresses and true denim for the boys' shorts. Nothing goes to waste, with the smaller pieces of fabric used for bows, pockets and headbands.

"We pray over everything that is being made. We want to make a difference in the lives of these children; their smiles are our prize," Pagan said.

FACULTY:

FINANCES:

The College offers top-quality postsecondary education at a very affordable cost. Financial aid is available to qualifying students through Federal, State, Denominational and local sources. Every effort is made to ensure that financial burdens on students are kept at the lowest possible level.

ACADEMICS:

The College confers degrees at the Associate, Baccalaureate, and Masters levels. We are grateful for another season of growth & impact among our family of churches. This year, we have presented estate planning workshops to over 750 individuals resulting in 45 new estate plans. We celebrate the generosity of God's people through Florida Baptist churches who want to "outlive their life" through an estate plan that expresses stewardship and generosity. In addition, we have seen over \$4M in total distributions YTD.

During our Convention video report, we will feature a Kingdom impact story about the **R. Niel Hampton Jr. Memorial Scholarship**. You will be encouraged as we are all reminded how our gracious God can bring hope and healing from deep pain and loss. See how this "normative" sized church is making a huge difference in the lives of many!

Speaking of Kingdom Impact – did you know that our Foundation's **Kingdom Fund** provides a long-term return for investors while directly investing in ethical bio-medical research which seeks to cure orphan diseases, US farmland, providing banking services for under-resourced people around the world, and other ways that promote human flourishing? This fund has over \$57M in assets with an average annual return of 7.2% since inception.



A few additional ministry highlights and celebrations:

- Total assets under management (Foundation and Church Growth Investment Fund combined) continue to grow to over \$337,000,000.
- Earlier this year we celebrated the annual distribution from the Florida One Fund, providing a total of over \$400,000 in resources to Send Network Florida, Disaster Relief, One More Child, The Baptist College of Florida, and in partnership with the Florida Baptist Convention, awarding 53 pastor/family theological education scholarships.
- So far this year, we provided 16 new loans to Florida Baptist churches totaling \$21.7M and have funded over \$263M to churches through the Church Growth Investment Fund since inception.
- Lastly, CGIF is currently offering a new 6-month time certificate for 5.0%

ENGAGE FOR CHILDREN

One More Child is steadfast in its mission to share the love of Christ with children who are abused, neglected, or disadvantaged. In 2022, we cared for **236,492 children and individuals** and provided **more than 14 million meals**. All of this was possible because of people like you who said "yes."

When you say "yes" to engaging for one more child, you help children like Tonya*, a teen girl in foster care. Tonya recently visited Loft 181, a ministry of One More Child that offers girls in foster care and survivors of sex-trafficking, a boutique-style shopping experience in a safe, nurturing environment.

Tonya came to Loft 181 with a group of foster children, laughing and joking as they selected from an assortment of items donated by generous supporters. At the end of the appointment, the Loft 181 team shared the Gospel with the girls, specifically about the nearness of God (Proverbs 18:24). Each girl shared their prayer requests; Tonya disclosed she was terrified by the uncertainty she faced as she aged out of foster care.

After the prayer, Tonya stayed behind as the girls departed, hoping to learn what it would look like for God to be near to her personally. That day, she prayed to invite Jesus to be "the friend that sticks close to her always."

The support from our churches has enabled us to serve more people in more places than ever before. By partnering with One More Child, you helped provide loving homes for foster children, warm meals for hungry children, hope and resources for single moms, and healing for survivors of child sex trafficking.




