

Standing Rules

Florida Baptist State Convention

Messengers are advised that the procedural rules that will govern the business sessions of the annual meeting are defined by the Bylaws, Florida Baptist State Convention, specifically Bylaw 1, titled "Rules of Order." The highlights of those procedural rules are as follows:

- **A. Rules of Order:** The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern the State Convention in all cases to which they are applicable and in which they are not inconsistent with the Bylaws of the Florida Baptist State Convention and these standing rules.
- **B. Standing Rules:** The Committee on Order of Business shall act as the Committee on Standing Rules in presenting any standing rules (parliamentary and nonparliamentary procedural rules) for consideration by the State Convention during the first session of the State Convention meeting.
- (1) The Committee on Order of Business, at the time it presents the program for adoption, shall call to the attention of messengers present, the existence of the following permanent rules that shall govern the conduct of business during the State Convention meeting:
- (a) For admission to the assembly hall, under certain conditions and at the discretionary order of the State Convention president, to facilitate identification and seating, messengers, visitors, and others may be required to wear the badge issued by the Registration and/or the Credentials Committees.
- (b) A resolution offered by an individual messenger(s) shall be in writing, signed by the maker who shall be a registered messenger to the State Convention, and shall be delivered directly to the desk of the Recording Secretary, after the resolution has been introduced. The introduction of a resolution shall be limited to only the title and/or topic of the proposed resolution being presented, with neither further explanation nor discussion. (See Guidelines for Handling a Motion of Resolution.)
- (c) No messenger shall speak in debate more than twice on the same question during the same session, for no longer than three minutes each time, without the permission of State Convention messengers who may grant such a privilege by a two-thirds vote without debate.
- (d) All reports and other material for the permanent record or printed proceedings shall be in typewritten form and, immediately on presentation, shall be delivered to the Recording Secretary.
- (e) Nominations for each elected office to be filled by the State Convention shall be limited to one nominating speech of three minutes for each nominee. Nominees for any elected State Convention office shall be: a registered messenger; shall have agreed to be nominated; and shall be present on the platform at the time in which they are nominated.
- (f) When more than one candidate is nominated for any convention office, a written ballot shall be taken from all registered messengers present and voting. The Teller's Committee, appointed by the State Convention President, shall collect the ballots, count the ballots, verify and certify the voting results. The chairman of the Teller's Committee shall provide to the State Convention President, on a timely basis as soon as is practicable after the respective vote, a written report on voting results. The report shall include the actual number of ballots cast, the number of votes received by each candidate, and the number of invalid ballots collected.

(2) All motions, resolutions and memorials, except those proposed by the State Board of Missions or by standing committees, and all recommendations made in reports of officers or committees of the State Convention, shall be referred to the Committee on Order of Business. The Committee shall determine appropriate disposition of these motions, resolutions and memorials. Motions of resolutions and recommendations proposed by the State Board of Missions or by State Convention Committees shall be presented by the Board or proposing committee directly to the State Convention, at a time designated by the Committee on Order of Business.

Guidelines

for Handling a Motion of Resolution

On November 13, 2000, the Administrative Committee of the State Board of Missions approved the following procedures for handling a motion of resolution.

- 1. During the first Miscellaneous Business session, a person introduces his/her motion or resolution by stating the subject. The presiding officer will seek to clarify, if necessary, the intent of the motion/resolution.
- 2. A written copy of the motion will be brought to the Recording Secretary's desk located at the front edge of the platform.
- 3. The Committee on Order of Business will set the time for discussion of the motion or resolution. If there is no other miscellaneous business scheduled, the committee could recommend consideration at the time the motion is made.
- 4. The time for discussion of particular motions/resolutions will be announced by the presiding officer.
- 5. At the appointed time set by the Committee on Order of Business, the maker of the motion will be permitted to speak to his/her motion/resolution. As a motion/resolution it will be considered by the Convention body, which may choose to debate, amend, table, refer, approve or defeat the recommendation.
- 6. The presiding officer, in consultation with the parliamentarian, will determine if a motion can be acted upon immediately, rule the motion out of order, or refer it to the Committee on Order of Business.

Gospel Partnership Enhanced With New Initiative Between The Salvation Army And Southern Baptist Disaster Relief

When crises wreak heartbreak and havoc in communities, The Salvation Army and Florida Baptist Disaster Relief step out in gospel partnership to offer nourishment not only for the body but also for the soul.

The two faith-based organizations recently launched a joint service initiative to ensure that every Salvation Army mobile feeding unit would be accompanied by trained chaplains to offer the hope of the gospel to those impacted by disaster.

"Chaplains are really the heartbeat of what we do. Even though people see the feeding and cleanup, we have a real emphasis on the spiritual component of what we do for survivors and for our own volunteers. Jesus gave us a mandate to meet the physical needs of people, but more so He gave us a mandate to meet the spiritual needs," said David Coggins, director of Florida Baptist Disaster Relief.

The new initiative was put into practice for the first time after Hurricane Debby made landfall in the Big Bend of Florida on Aug. 5 and the two crisis response organizations partnered in relief efforts.

"We are excited about all that has come together over the past year to strengthen our partnership with The Salvation Army and believe this will greatly expand opportunities to bring compassionate help to those impacted by disasters not only in feeding but also in providing emotional and spiritual care to survivors. This demonstrates the love of Christ to hurting people and has potential to expand both organizations' kingdom impact," said Coy Webb, crisis response director for Southern Baptists' Send Relief.

Dale Simmons, state chaplaincy coordinator for Florida Baptist Disaster Relief, agrees. "This partnership is significant as it leverages the strengths of both organizations to provide a more robust and effective disaster relief effort in Florida and potentially beyond," he said. Simmons noted that the partnership is significant in five ways: resource sharing, broader reach, efficient coordination, increased support and funding, and enhanced training and preparedness.

Providing chaplain support to The Salvation Army, Webb pointed out, "is one of our greatest opportunities to solidify our relationship and to provide greater ministry to the broken and suffering. The recent work between Florida Baptist Disaster Relief and The Salvation Army is a shining example of this great opportunity to increase the work of Christ through partnership," he said.

'Want to feel heard and seen'

In a disaster's aftermath, community residents, who are "often desperate and at the end of their resources," gather in long lines with their neighbors to receive much-

needed food and water. "Many are in tears because they can't see past their seemingly hopeless situation," said Major Leisa Hall, area commander in the Florida Division of The Salvation Army.

Grateful for the food and water, she said, many of these disaster survivors want more. They "want to feel heard and seen."

Emotional and spiritual care offered by volunteers from The Salvation Army and Florida Baptist Disaster Relief "can provide a listening ear, Scripture verses, prayer and other benefits beyond food and water," she said. The "ultimate victory," she added, of these "meaningful conversations" is "when the disaster survivor comes to faith in Jesus."



In a rural Florida community during the recent Hurricane Debby response, Monique, a Salvation Army volunteer who is trained in emotional and spiritual care, accepted the outstretched hand of a young man who requested prayer for himself and his girlfriend. After Monique prayed over the couple, the man, with tears in his eyes, thanked her for not only being there to meet their physical needs but also for demonstrating that someone cares for them and what they have been through.

Also during the Hurricane Debby response, Cindy Weldon, a Florida Baptist Disaster Relief chaplain, connected with a homeless man who shared a "compelling story" he had never shared before. "Throughout our time together, we experienced moments of both laughter and tears. According to him, throughout his life, he had never experienced someone treating him with respect or showing genuine care for him as an individual," she said.

Such stories are shared often as Florida Baptist Disaster Relief and The Salvation Army join together to "share a gospel witness or minister in other ways to people" who are distraught in a disaster's aftermath, Coggins said.

The new partnership initiative, he said, "is a great opportunity to expand our ministry reach."

Fellowship Of Hispanic Baptist Churches Of Florida Celebrate And Recommit To Missions At Home And Abroad

HIALEAH— Florida Hispanic Baptists traveled from all over the Sunshine State and met at Iglesia Bautista Northside in Hialeah to celebrate and motivate one another to remain united in missions.

The gathering drew approximately 450 individuals representing 55 Hispanic Baptist churches from the Southeast, Southwest, Central and East regions. Because the North and West regions were under tropical storm watch, individuals from those regions were unable to make the trip.

During his biblical message, Northside pastor Alberto Ocaña extended an invitation to all who desired to respond to a calling to missions ministry.

"It's not enough to go to church on Sunday; we have to take the gospel message to the lost world," he said. "If we are not proactive in sharing the gospel, many will be lost, and the church will not grow."

Many answered the call for the first time, while others renewed their commitment to live their lives on mission.

Present at the event was Moises Bermudez, a young member of Iglesia Bautista Dios es Bueno in Daytona Beach, who spent three months as a missionary in Puerto Rico through a partnership with the North American Mission Board's Send Relief. A dozen Hispanic church planters representing all regions of Florida were also in attendance, showcasing the sending culture among Hispanic churches that is growing.

Manny Barahona, president of the Fellowship, encouraged those gathered to be on mission "because God is with us." He also shared his dream for Hispanic churches in Florida.

"My dream is that our Baptist churches in Florida will continue to grow in the name of Jesus, that they may continue to raise up men and women who will preach the gospel, that every year more people will be baptized, that every year more churches will work together. And, when we gather like we are doing today, we can talk about the great things God is doing among us."



In addition to hearing from Send Network's Español new vice president Jose Abella, the group also watched a video from the International Mission Board celebrating how Hispanics are on mission across the globe. Featured in the video were three Florida Baptist pastors and three Florida Baptist women who traveled to Spain to work alongside Hispanic missionaries reaching Muslim immigrants. Those pastors continue to travel to the region as part of their partnership with the International Mission Board.

Tommy Green, executive director-treasurer of the Florida Baptist Convention, although unable to attend the gathering, sent a video message. "My heart is full of joy and gratitude for how we have been together on mission. There are many things that could separate us, but we have chosen to be united for the gospel of Christ."

6. 2023 Maguire State Mission Offering Report

The 2023 Maguire State Mission Offering was directed by the State Board of Missions toward the Send Network Florida Initiative. By utilizing the state mission offering to create an additional funding source for church planting, it allows every Florida Baptist church contributing to the Maguire State Mission Offering to be a supporting church of the Send Network Florida church planting partnership between the Florida Baptist Convention and the North American Mission Board.

With the close of the Convention's accounting year on December 31, 2023, a total \$707,019 was received for the year 2023 Maguire State Mission Offering. The 2023 total represented 80% of the offering goal of \$880,000. The total number of entities contributing to the offering decreased to 491 from the 504 participating the prior year. We are encouraged by the continued partnership in the annual offering as we reach towards this goal.

During the November 2023 meeting, the board approved and recommended the temporary release of restrictions related to the endowment it established at the Baptist University of Florida in the amount of \$750,000 for the John Sullivan Chair of Baptist History,

with the expectation that immediately upon receiving any level of financial settlement relating to its insurance claim arising from the property damage caused by Hurricane Michael in 2018 that the endowment corpus will be restored to the original amount of \$750,000 and the original restrictions, as defined in the original endowment agreement, will be reinstated. Additionally, the university provides regular updates to the State Board of Missions related to their progress with the insurance settlement.

26. Florida Baptist Historical Society: Appointment of Board of Directors

The Governing Document of the Florida Baptist Historical Society provides that a full term shall be three years and that a "board member shall be eligible to serve two full terms of three years each." One current board member – Mrs. Arlene Vause – was appointed in 2019 to fill an unexpired term which was to conclude December 31, 2021, of a deceased Board member. The Society's Governing Document, Section IV, sub (2), further provides that, "When a member is elected to serve an unexpired term, the member then shall be eligible to serve two full terms." In 2021, Mrs. Vause was appointed to her first full term from 2022 to 2024. During its meeting on August 30, 2024, the State Board of Missions elected Mrs. Arlene Vause to the Historical Society Board for the term from January 1, 2025 to December 31, 2027.

27. Recommendation to Transfer Property Located at 7854 W Dunnellon Rd, Dunnellon, FL

During the February 2024 meeting, the board authorized the Executive Director-Treasurer to execute all legal documents necessary to transfer ownership of this property to the First Baptist Church of Dunnellon, for the purpose of establishing a church plant in that location.

During the April 2024 meeting, the board learned that the court granted the convention's motion for summary judgement on February 13, 2024, officially and legally transferring the title and ownership of the property to the convention. On March 11, 2024, the deed, which included a restrictive covenant that would continue to protect the property into the future, was executed by the convention and delivered to First Baptist Dunnellon, completing the property transfer. In July 2024, First Baptist Dunnellon successfully launched Lake Rousseau Baptist Church at the site.

28. Accreditation with the Evangelical Council for Financial Accountability

During the April 2024 meeting of the State Board of Missions, the board was notified that in February 2024, the convention received the milestone achievement of accreditation with the Evangelical Council for Financial Accountability. This will be an annual reaccreditation process going forward in an effort to remain committed to the highest levels of financial accountability.

29. Information Technology System Enhancements

During the April 2024 meeting, the board received a report on the detailed status and improvements within the convention's information technology system. This will continue to be provided annually to raise general awareness of IT systems, their status and planned/ongoing improvements as we seek to carry out fiduciary responsibilities.

30. Retirement of Executive Director-Treasurer of the Florida Baptist Convention

During the April 2024 meeting, the board received the announcement that Dr. Tommy Green intended to retire by December 31, 2024. He had served as Executive Director-Treasurer of the Florida Baptist Convention since 2015.

31. Election of New Executive Director-Treasurer of the Florida Baptist Convention

During a special-called meeting of the State Board of Missions on July 18, 2024, the board unanimously elected Dr. Stephen N. Rummage as Executive Director-Treasurer to begin service effective August 17, 2024.

32. Recommendation to Establish Position of Special Advisor to the Executive Director-Treasurer

During the special-called meeting of the board on July 18, 2024, the board recommended the adoption of the position of Special Advisor to the Executive Director-Treasurer and named Dr. Tommy Green to this position. He will serve in this position until December 31, 2024.

33. Distribution of Proceeds from Sale of Convention Property Located at Southwest 104th Street, Miami Dade County

During the November 2023 meeting, the board was notified of the opportunity to sell the property located at Southwest 104th Street, Miami Dade County, and authorized the executive director-treasurer to sign a listing agreement with a real estate brokerage firm; and authorized the corporate officers of the State Board of Missions, as the Board of Directors of the Florida Baptist Convention, Inc., in consultation with the Convention's legal counsel, to sign the appropriate legal agreements and/or quitclaim deeds to execute the sale and legal transfer of the property located at Southwest 104th Street, Miami-Dade County, Florida, from the Florida Baptist Convention, Inc., to the successful buyer; and the proceeds of the sale be held until the board can authorize the distribution of proceeds from the sale.

In the August 2024 meeting, the board was notified that the sale had been completed on June 28, 2024, for \$2,180,000. The board authorized the distribution of proceeds from that sale during this meeting.

Resolution Against the Proposed State of Florida Constitutional Amendment 3 (Adult Personal Use of Marijuana)

The board continued to take action on behalf of Florida Baptists to protect against the legalization of marijuana. During the August 2024 meeting, the board, acting in its capacity to serve ad-interim on behalf of messengers of the Florida Baptist State Convention, adopted the following resolution on behalf of Florida Baptists.

A Resolution of the Florida Baptist State Convention Against Legalizing Adult Recreational Marijuana WHEREAS, in the upcoming state election, Floridians are being presented with a proposed amendment to the Florida State Constitution (Amendment 3) that would legalize the adult use of recreational marijuana; and

WHEREAS, throughout Holy Scripture, we are directed in how we should live out our lives in honor of our Lord and Savior (I Corinthians 10:31 and 9:27, Colossians 3:2); and

WHEREAS, the Bible provides clear warnings as to what will happen if we subject our bodies to the vices of this world (Galatians 5:19-21); and

WHEREAS, providing legal access to marijuana for recreational use will only lead to the further decay of our society and would be a detriment to the citizens of our state; be it

RESOLVED, that the State Board of Missions, acting on behalf of the Florida Baptist State Convention, calls upon all disciples of Jesus Christ, who recognize the human body as a temple of our Lord and Savior, to unite together in renouncing the proposed Amendment 3 - Adult Personal Use of Marijuana; and be it further

RESOLVED, that we call on all Florida Baptist pastors to implore their congregations to mobilize and make their voices heard by voting against Amendment 3 on or before the November 5, 2024, election.

35. Sanctity of Life

The board has continued to take action on behalf of Florida Baptists to protect the sanctity of all human life. During the April 2024 meeting, the board was notified of the proposed State of Florida Amendment 4 "Amendment to Limit Governmental Interference with Abortion" and approved the release of the following statement denouncing the proposed amendment.

"Florida Baptists are aggrieved at the heart-wrenching loss of human life that occurs through abortion. We are further distraught at the drastic death toll that will be incurred if Floridians pass the proposed constitutional amendment titled "Amendment to Limit Government Interference with Abortion." Florida Baptists implore our fellow citizens to stand against this ballot initiative and to protect the pre-born children who would face needless death if the proposed amendment passes."

In this same meeting, the board authorized the Executive Director Treasurer or his designee to engage with all like-minded organizations in the state of Florida that share the same concern of protecting the pre-born, and requested cooperating ministry, Florida Baptist Children's Homes d/b/a One More Child, extend any and all effort, including use of prolific contacts to educate Floridians of the detrimental impact on human life this amendment would have, including reallocation of \$100,000 of Cooperative Program financial resources to fulfill this educational campaign.

In the August 2024 meeting, the board, received an update regarding actions taken up to this point. Additionally, the board, acting in its capacity to serve ad-interim on behalf of messengers of the Florida Baptist State Convention, adopted the following resolution relating to the proposed State of Florida Amendment 4 (Amendment to Limit Government Interference with Abortion).

A Resolution of the Florida Baptist State Convention to Protect Human Life in the State of Florida

WHEREAS, Florida Baptists have remained steadfast in the inerrancy of God's Word found in the Holy Bible (Genesis 1:27), which declares that God is the creator and giver of life and forms every human in his image; and

WHEREAS, in the upcoming state election, Floridians are being presented with a proposed amendment to the Florida State Constitution (Amendment 4) that would seismically impact pre-born lives by allowing the abortion of children up to the point of viability; and

WHEREAS, Florida Baptists continue to champion God's design for life from the moment of fertilization (Psalm 139:13-14), and that God declares, through Holy Scripture, that the taking of an innocent life is a moral evil (Exodus 20:13); and

WHEREAS, the Florida Baptist State Convention has authorized the State Board of Missions to act on its behalf ad interim in moments where timeliness is of the essence; and

WHEREAS, the upcoming statewide election will occur before the Florida Baptist State Convention convenes the next time in annual session, and the convention must be on record speaking against the proposed amendment; be it therefore

RESOLVED, that the State Board of Missions, acting on behalf of the Florida Baptist State Convention, calls upon all disciples of Jesus Christ, who desire to obey God by protecting human life and loving our neighbors (Mark 12:31), to unite together in renouncing the proposed Amendment 4; and be it

RESOLVED, that we call on all Florida Baptist pastors to implore their congregations to mobilize and make their voices heard by voting against Amendment 4 on or before the November 5, 2024, election; and be it further

RESOLVED, that Florida Baptists ask all civil servants at every level of government in our state to join with us for the sanctity of human life and renounce the proposed amendment.



Fruit Cove Baptist Expands Missions Outreach To All Seven Continents

ST. JOHNS-With its recent mission trip to Australia, Fruit Cove Baptist Church in North Florida has reached its goal of extending its missions footprint to all seven continents.

While it's something the church has celebrated, Jonathan Wilson, the church's families and missions pastor, will tell you the church still has more to do.

"That's the one thing about ministry – you never get to the point where you are done," he said. "You have wins. You have some things to celebrate. But it's about helping people get discipled and get mobilized so they can see how God can use them now to make a difference."

Through a combination of short-term mission trips and partnerships over the past seven and a half years that Wilson has been on staff, the church was able to reach this goal, including the mobilization of 160 people to six continents on 17 trips in 2023 alone. Wilson said he was initially inspired by Tim Maynard, now pastor emeritus at the church, who shared his desire for reaching all the continents.

"It's all about relationships," Wilson said in describing how he got started on this initiative after coming on church staff. He began with some existing partnerships the church had in Central and South America, and then expanded on that. He also looked to the North American Mission Board and International Mission Board to establish connections with missionaries and ministries already in place.



"NAMB and IMB are both very supportive and great resources for us to find people on the ground who are getting it done, people we can trust and come alongside with prayer, support and resources." he said.

Fruit Cove Baptist currently partners with about 32 church plants throughout North America. Here is a look at the church's missions work on the other six continents.

EUROPE: In London the church partners with an IMB church planter who has started the first evangelical church in his hometown of Wroughton, just outside of



London. "We partner with the work there and will be sending a team to the UK over spring break," Wilson said. "We also have several families who've adopted specific Wroughton streets to pray for on a regular basis."

ASIA: Kuala Lumpur, the capital city of Malaysia, has been designated as a key global city by the IMB, and Fruit Cove wanted to be part of that emphasis. Fruit Cove partners with a church plant there. A family from Fruit Cove helps lead the church plant. The church is planning to send a team next fall.

AFRICA: To adopt an unreached people group, the church has partnered with an IMB unit that is working hard to reach a nomadic group located in the Horn of Africa. Two church members traveled to the Horn to establish connections and were introduced to Christ followers among the people group, including one young man who uses a radio program to broadcast the gospel in the area. The church helped fund that ministry and is now sending four people there in February.

CENTRAL AND SOUTH AMERICA: Guatemala was one of the first mission trips for the church in 2015. It's a compassion-type ministry where teams build one or two houses and do food distribution and children's ministries. The church now sends three teams annually to Guatemala and have expanded to include components of medical and dental ministries. Now the church has expanded into South America with church planting and children's Bible clubs in Ecuador.

STATE BOARD OF MISSIONS Recommendations to the Florida Baptist State Convention

Recommendation 1:

2025 Florida Baptist Convention Budget

The State Board of Missions recommends that the Florida Baptist State Convention adopt the year 2025 Cooperative Program Basic Budget of \$29,500,000 based on the following distribution and the general detail as noted in the attached budget document:

(a) That all Cooperative Program income receipts be distributed on the following percentage allocation:

Southern Baptist Convention causes 51.00% Florida Baptist Convention causes 49.00%

(b) And that the Cooperative Program Basic Budget designated for Florida Baptist Convention causes (or 49% of total Cooperative Program income) be distributed on the following basis:

Total Florida Baptist Convention \$14,455,000

Convention Programs of Mission, Ministry, and Support \$12,063,000

Cooperating Ministries\$2,392,000Baptist University of Florida\$1,320,000Florida Baptist Children's Homes\$912,000Lake Yale Baptist Conference Center\$160,000

(c) (c) That all Cooperative Program receipts received by December 31, 2025, and which are in excess of the budgetary requirements specified within the 2025 Cooperative Program budget shall be designated as Cooperative Program Excess Budget funds.

Additionally, we direct 51% of such excess funds be immediately distributed to the Cooperative Program of the Southern Baptist Convention. Further recommendations and subsequent board action on the distribution of the remaining 49% of Excess Budget funds shall be in keeping with the State Convention's Business and Financial Plan [Bylaw 16, B (3)(a)(b), Bylaws of the Florida Baptist State Convention].

(d) Furthermore, the convention recognizes the autonomy of each local church and the decisions that each may make regarding cooperative giving to Southern Baptist Convention causes. As such, the convention will appropriate gifts to cooperative causes as directed in writing by a local church.

Cantonment Church Plant Celebrates 11 Baptisms

CANTONMENT-It's not just a place to become physically strengthened, it's a place to become spiritually strengthened.



At just a few months old, Living Truth Church in Cantonment needed a place to meet. Pastor Jeff Cranford kept searching for just the right home for his church plant, but he kept seeing door after door closed. Just when a church home seemed out of reach, Cranford reached out to the owner of a local gym and discovered that the owner loved the Lord and had been praying about church planting for some time. It was a perfect partnership with the gym already having office space and a children's area that could serve the needs of families on Sunday mornings during church services.



The church plant barely had time to settle into its new home before the celebrations began.

As the church plant celebrated 11 baptisms in its first four months, Pastor Cranford commends church members who are actively sharing their Christian faith.

"We have seen our people go out and share the gospel and lead people to Christ,

resulting in baptisms. It's amazing to see the body of Christ do what it was commissioned to do outside of the four walls of the church," he said.

Cranford began his ministry career as worship leader at Living Truth Church in Pace, which planted the church campus in Cantonment. Cranford then led student ministry and, next, he said, that God "stretched me and guided me" to pastor the church plant.

"It's my desire to see people reached with the gospel of Jesus Christ and discipled to live in obedience to Him and make disciples that make disciples," Cranford said.

Miccah Pocopanni serves as part-time worship leader. The church provides nursery classes and children's ministry, and it plans to launch a student ministry in the fall. A women's ministry is led by the pastor's wife.

Church planting is multifaceted, requiring a lot of faith, work and perseverance. Cranford is grateful he's not alone in the church planting venture. Several Living Truth Church families in Pace sensed God's call to be a part of the work in Cantonment and have helped with various aspects of ministry.



"Being the pastor of a church plant can cause you to have your hands in various tasks, but our team is great at sharing the load. I try to focus on teaching, praying, meeting with people and shepherding and steering the general direction of the church," said Cranford.

In less than half a year, the new church has grown from an average of 60 to 80 in weekly attendance.

To strengthen its ties to the community, Living Truth Church in Cantonment plans to mobilize small groups for monthly service projects, including ministry to local schools and to families at ballparks.

The Committee on Nominations of the Florida Baptist State Convention presents the following report for consideration and action by the Florida Baptist State Convention, November 11-12, 2024.

Persons listed in the sections "Nominees for Election" are being recommended by the Committee on Nominations for election by the state convention.

Names listed in the shaded areas are for **information only**. These members are currently serving and are not subject to action by the convention in the year 2024.

STATE BOARD OF MISSIONS

The State Board of Missions is composed of members elected by the Florida Baptist State Convention from within the bounds of each of the six ministry regions. The regional distribution of board members is to be made on the following basis of church membership as recorded in the annual statistical report for the prior year: (1) One board member for 1-7,500 church members which shall increase by one for each additional 7,500 church members or portion thereof; (2) Total membership on the board shall be no more than 99 members and no less than 90; (3) No ministry region may be permitted more than 22 elected board members; (4) Each cooperating association shall be represented by a minimum of one member from one of its cooperating churches; (5) No association may be permitted more than five Board members; (6) At least one elected board member shall come from a church affiliated with the FBSC as a Church-at-Large; (7) In no instance will more than six elected board members come from churches affiliated with the FBSC as a Church-at-Large, with no more than two Church-at-Large representatives coming from any one of the six ministry regions.

Lake Rousseau Baptist Church: 'Out of the ashes' ... to 'bring about great things for His kingdom'

DUNNELLON-Pastor Jim Kinnebrew sometimes feels like God parachuted him right down in the middle of a new church plant.

He and his wife Sandy just launched Lake Rousseau Baptist Church in Dunnellon in July, and they feel blessed that they already have a beautiful church building on a 10-acre site, and that they've been welcomed by people in the area who say they have been hoping and praying for a church to come to that site.

Many church plants are not as fortunate, often meeting in homes or temporary locations for a period until they find a more suitable building. And they're not always met with prospective members praying for their arrival.



"It's hard to think that this was not all planned by God," Kinnebrew said.

The new church launched on July 14 with a little more than 100 people in attendance. A photo posted to the church's Facebook page that day shows a big crowd practically spilling out of the pews. With many of those being well-wishers there to support the opening, attendance has since settled down to about 50 each week, the pastor said. But their numbers continue to grow, attracting new visitors each week.

The church has attracted many senior citizens, which reflects not only the surrounding area but also the pastor, who is 71, and his wife. Young families with children also have been coming to check the church out.

In addition to Sunday morning services and Sunday School, the church is continuing with its Wednesday night dinner and Bible study, which it started doing back in May with its core group. Each week, one person makes the main dish, and everyone else brings a side dish or dessert. All are welcome.

"Folks are loving the community dinners on Wednesdays," he said. "They love getting out and getting to know their neighbors, and they like the solid Bible studies."



Kinnebrew has a doctorate degree in theology, and he taught for 33 years at Luther Rice Seminary in Atlanta. When he and his wife retired three years ago back to the area where they both grew up, he did not expect that he would be pastoring a church as he is today. Teaching a Bible study and doing some supply preaching, sure, but not leading a church, he said. The couple had dreamed of doing some traveling in their RV.

'Beautiful thing' to 'work together'

They began attending First Baptist Church of Dunnellon, and one day late last year Pastor Russ Randall invited him to lunch and asked him to consider being the pastor of this new church plant. The previous church membership had disbanded, and the church building sat empty for almost three years due to some legal issues.

Kinnebrew eventually said yes, and he and his wife traveled to Atlanta in February for church planter training and screening with the North American Mission Board.

As the sponsoring church, First Baptist Church of Dunnellon challenged its membership to take part in this church plant in three ways:

- 1. Commit to pray for this new church plant.
- 2. Pray about being a financial supporter and giving a monthly donation.
- 3. Pray about moving to this church for one year.

Fort Myers Church Committed To Spend 'Less On Ourselves,' Give 'More To Missions'

FORT MYERS – When it comes to fulfilling the Great Commission, Crossroads Baptist Church in Fort Myers has discovered that less is more.

"The Great Commission [Matthew 28:18-20] is in our conversations, teaching, small groups. ... Everywhere we go, the gospel goes; and everywhere we go, we are on mission. We are striving to be a church that spends less on ourselves and gives more to missions," said David Gold, senior pastor of Crossroads. He explained that 17% of the church's annual budget is earmarked for missions, in addition to the church's emphasis on special offerings such as the Lottie Moon Christmas Offering for International Missions and the Annie Armstrong Easter Offering for North American Missions.



Along with committing to increase its missions giving by one percentage point annually and "giving more and more toward kingdom ministries," with the ultimate goal of the church giving 30% or more to missions, Crossroads also is committed to praying vigorously for its community, other local churches, and its national and international church partners.

"We pray for missions, our city, other local churches, and our partners consistently in our services," Gold said.

Generous giving and vigorous prayer ultimately lead to the church being directly involved with missions and working with full-time missionaries, which further fuels the church's outward focus. When church members return from mission trips, Gold said, "We celebrate what God has done before our people."

Engaging in missions and keeping evangelistic fervor before the people takes intentionality and constant celebration, Gold said. "By sharing their experiences, creating videos, developing partnerships, we have learned that whatever gets celebrated, gets repeated."



Local Community

Crossroads Baptist Church's missions commitment is lived out with various outreach and layperson-led ministries throughout its local community.

"We encourage our people to live out personal ministry. We want to equip the saints and encourage them to catch the power and vision of the gospel," said Michael Caro, youth pastor at Crossroads.

Equipping the saints to do the work of ministry has evolved into a food pantry distribution that feeds more than 275 families a month, a juvenile prison ministry, One More Child volunteer team, an active and thriving Good News Club and more.

The southwest Florida church also has adopted five public schools in Lee County to offer support and encouragement, partners with Iglesia Real Fort Myers Church, and ministers through Ride Nature—a ministry that seeks to serve extreme sports enthusiasts, one of the largest unreached people groups in the world.

"We seek to be a church that if we ceased to exist, we would be deeply missed by our community," said Gold.

Have you ever thought about how many times in your life you have said yes? Sometimes our "yes" can be a simple affirmation to a mundane daily decision. We say yes when we decide where to eat, where to go for a family vacation or even what to wear every day. But then there are times where we have an opportunity to say yes to God. These are moments of divine appointment where our response to God's invitation can forever shape the narrative of our life. At FBFS, we understand the significance of this "yes" and make it our mission to help every individual, family and church fulfill God's call by saying yes to His plan and their specific calling.

There are many ways we help people and churches say yes such as planned giving, cash management and church loans. We believe that when we say yes to God, more churches are planted, more missionaries are sent, the gospel is extended further into lostness, and a Kingdom legacy can be both planned and fulfilled. Florida Baptists – because of your "Yes" to partner with our ministry, we have been able to see God do amazing things in this season:

- Total distributions YTD are \$2,068,276 with \$601,151 going to churches and associations, \$377,062 to Theological Education & Scholarships, \$473,299 to SBC Missions and \$230,779 to One More Child.
- Since our 2023 Convention meeting last November in Tampa, \$580K went directly from the Florida1Fund and the Florida Baptist Retired Shepherd's Fund to a variety of Florida Baptist mission causes.
- Through July, four FBC churches in Pace, Dade City, Apopka and Poinciana received a total of \$11,750,000 in new capital through loans to buy, build or renovate church facilities.
- Since January, the total cash and investments in the Church Growth Investment Fund grew by \$11.5M with 53 new accounts with a total of \$6.4M from new individual and church clients.
- In partnership with the Florida Baptist Convention, we provided 88 scholarships to pastors and immediate family members pursuing theological education as they prepare for ministry leadership across Florida.

- Our flagship Kingdom Fund has earned 7.3% since inception (09) while making an eternal impact through Biblically responsible screening and investing in a variety of redemptive causes.
- During the current year, the Lord has grown our total assets under management to a new high of \$391,637,854. This represents a cumulative growth of 75% since 12/31/2019.

While these numbers speak to God's faithfulness and the generosity of Florida Baptists, there are also great Kingdom stories that paint the fuller picture. Here is one story that reminds us that **Every Yes Matters...**

A little over five years ago, we said "yes" to partnering with First Baptist Daytona Beach in their relocation and construction of their new worship facility. During a time when the church was at a critical crossroads, the Lord led our leadership to engage with this church to. Five years later, the church construction & relocation is complete - they are in their new facility and their ministry is thriving. Pastor Eric Stitts recently shared with us that because we said yes, FBC Daytona is now able to say yes to seven mission partnerships around the globe, a weekly feeding ministry to hundreds in their community and they recently saw fourteen professions of faith through their summer VBS.

God continues to move powerfully through the ministry of Lake Yale Baptist Conference Center, impacting lives from diverse backgrounds and circumstances. This year, we hosted 360 different groups, with an average size of 60 or more people, staying and average of 3.8 days, providing a sacred space for reflection, discipleship, and evangelism. Each moment spent here is an opportunity for God to work in the hearts of His people, whether it's through a pastoral sabbatical, a youth camp, a men's gathering, or one of Lake Yale's programmed events.

One guest shared, "I was the only one able to come from our group. The others were home sick. After settling into the room, I met a few ladies playing cards who invited me to join them. They welcomed me into their group, and now I'm looking forward to meeting them again next year. They were from Lakeland, where my son lives, and I want to tell him about their church!"

Youth groups are seeing God move mightily as well: "We had over 170 decisions during youth week, including a student who recommitted his life to Christ. Another leader shared, "We had so many students commit their lives to Christ, a lot of whom had no previous background with the church. God was moving greatly!" Other youth leaders reported, "Six students dedicated or recommitted their lives to Jesus, and thirteen made decisions to answer the call to ministry."

Even our pastoral sabbaticals have provided life-changing moments: "God gave me amazing times of prayer and solitude, much-needed rest, and sent me back to my pastoral assignment with joy and thanksgiving."

This year, we are excited to highlight the updated Bunkhouse, which has become a favorite new feature, offering comfort and space for groups of all sizes. Alongside this, our new amenity additions have enhanced the overall experience for all visitors, from youth to seniors.

Church And Christian Academy Partner To 'Pray And Obey, Love' Christ Well, Share God's Love'



WINTER GARDEN—What is the secret to a spiritual awakening taking place among students in central Florida?

It's really no secret at all.

First Baptist Church in Winter Garden and Foundation Academy, a private Christian school in Winter Garden, have partnered together to integrate the gospel into every aspect of students' educational life, resulting in a campus-wide spiritual revival.

"All we've done is pray and obey, love Christ well, and share God's love with the students through every available avenue," said John Bradley, student ministry director at First Baptist Church in Winter Garden.

Over this past 2023-2024 academic year, this intentional gospel integration into daily school activities has seen countless students "come to understand that there is a difference between having knowledge about the things of God and following through on them in faith and obedience," Bradley said.

Many students have made professions of faith in Jesus as they realized that a Christian commitment "takes more than behavior to 'be good enough,'" Bradley said. "It requires surrender to the lordship of Christ," which includes following through "in obedience" in matters such as baptism, church involvement, serving or personal discipleship.

First Baptist Winter Garden pastors and Foundation Academy faculty say the movement of God among the students started in September 2023 when Bradley and

Jeffrey Lawrence, director of spiritual development at the school, began to teach more directly on doctrine and theology—challenging students to think more intentionally about their personal relationships with God.

"We began to teach more directly on theology and doctrine, primarily who God is, how we can know Him, and what He produces in us. Students were challenged to evaluate their relationship with God and test its foundation," Bradley said.

Spiritual transformations taking place at Foundation Academy are evident on the high school baseball team. What started as one coach sharing his testimony with the players after practice launched an immediate response. After players and students were challenged to understand that nothing else matters aside from a genuine relationship with the Lord, several players responded with salvation decisions, resulting in numerous baptisms.

Bradley also credited the spiritual awakening to longtime, diligent prayer, saying, "The faculty and staff have prayed long and hard over these students and this school."

Foundation Academy, Bradley said, is now "reaping" the harvest of years of prayer and preparation by both church and school leaders.

"We're realizing the vision Tim Grosshans, senior pastor at First Baptist Winter Garden, and Dave Buckles, president of Foundation Academy, had years ago and what this place should be. We are reaping the reward now of years of preparation and diligently seeking the will of God by this leadership and faculty," Bradley said.

Genuine, organic life change

With leaders' priority on foundational doctrine and prayer, the students are living out their genuine love for the Lord, which is leading to "organic discipleship" campus-wide.

What is taking place at Foundation Academy isn't overwhelming chapel invitations and extended prayer services, but rather one-on-one conversations taking place around campus, in classrooms and at after-school practices, Bradley said.

"Students are seeing faith lived out by others, whether that be through peers, faculty or their pastors," he said. "It's the work of the Spirit through the believers displaying a genuine and effective faith. It's a, 'Let's do this together,' rather than a, 'Do as I say' attitude."



When asked if he could describe what is happening on campus in two words, Bradley described it as "lifestyle testimonies."

"It's genuine believers living out what God has developed in them," he said. "It's not fake, superficial or manipulative. It's real-life stuff happening with ordinary people in divine ways."

Vital church partnership

The faculty, leadership and pastors believe that this recent evangelism explosion and genuine life change are the result of a strong and vital partnership between the church and academy.


With First Baptist Winter Garden church members serving as board members for the school, the cohesive partnership between the two has developed into family-centered mission and discipleship over the years.

"The church functions as a spiritual accountability and guidance entity, allowing the school flexibility in how it applies matters of faith in daily student life," Bradley said. "The church directs the faith doctrine and theology, and the school implements the formation process."

Because the private school is not a "covenant school," meaning that students don't have to profess faith in Christ to attend, a large portion of students do not know God or actively attend a local church. Therefore, Foundation Academy is a ripe mission field for "many faith decisions and baptisms," Bradley said.

"Many students are truly professing the message of the gospel for the first time!"

5,000 Western Cubans Walk Into New Year With New Life In Christ



WESTERN CUBA-As 2024 dawns, close to 5,000 Western Cubans are walking into the new year with new spiritual life found only in Jesus Christ.

During a recent mission trip to the island nation, eight Florida Baptist leaders came right beside Western Cuba Baptist leaders for eight days of evangelistic outreach and preaching, resulting in 4,820 professions of faith. While there, the Florida Baptist leaders divided into teams of two and preached in 45 churches and missions scattered across the provinces of Villa Clara and Cienfuegos.

Florida Baptists have partnered with the Western Cuba Baptist Convention since 1997. It is a "true partnership" characterized by Florida Baptists' "heart of servanthood," said Kurt Urbanek, International Mission Board strategy leader for Cuba.

In his several visits to Cuba during the partnership, Myles Dowdy, Florida Baptists' catalyst for missions and ministries, stated that he has met many Cubans who are yearning for "the hope of Jesus Christ."

Mission team member Zach Terry, pastor, Fernandina Beach First Baptist Church, agreed with Dowdy, saying in a social media post, "Through the gospel of Jesus Christ, there is always hope."

Reflecting on the Florida Baptist team's trip to Cuba, mission team member Phillip Hamm said, "I was amazed at how receptive the people of Cuba were to the gospel.



Not only were they very hospitable and friendly, but they also have a sincere hunger for spiritual things."

Fred Pitts, recently retired pastor of Ancient City Baptist Church in St. Augustine, added, "I was impressed with the commitment of the Cuban 'missionaries' working alongside us during the day and the receptivity of the people to the gospel. These missionaries were laypeople from another part of Cuba as well as members of the churches we served."

This mission trip marked Pitts' first visit to Cuba. The pastors there, he said, "were not only very committed to Jesus, to their churches and to Cuba as a nation in need of God's love, but they were also well trained and solid students of Scripture.

"And the people were so very receptive! They were welcoming and friendly and excited to hear words of hope from God and His word. It is clear that God is moving among the churches and people in Cuba."

Pastor Manuel Barahona had not planned to go on the Western Cuba mission trip; too many details seemed to be getting in the way of him going. Yet, the issues keeping him at home were resolved, and he joined the mission team.

"This trip in many ways changed my life," said Barahona, pastor of Westside First Baptist Church in Boynton Beach. His takeaway? "The church in Western Cuba is alive and well. All I can say is, 'Praise God."

"Our priority while we were there was getting the word of God out and supporting our brothers and sisters. I'm ready to continue to do anything and everything I can to help. I'm in."

Barahona recalled preaching one night as he held a lantern to read Scripture. The church was dark due to an unexpected power outage.

"Although we came and wanted to preach and bless the people; it was the other way around. I received the blessing," he said.

The recent mission trip was the fourth time in Cuba for Al Fernandez, Florida Baptists' Southeast region catalyst. This time, in particular, he said. "We saw evidence of the gospel spreading like wildfire."
