

## Florida Baptist State Convention Committee on Nominations Potential Vacancies 2025

#### STATE BOARD OF MISSIONS

(99 Members)

The State Board of Missions is composed of members elected by the Florida Baptist State Convention from within the bounds of each of the six ministry regions. The regional distribution of Board members is to be made on the following basis of church membership as recorded in the annual statistical report for the prior year: (1) One Board member for 1-7,200 church members which shall increase by one Board member for each additional 7,500 church members or portion thereof; (2) Total membership on the Board shall be no more than 99 members and no less than 90; (3) No ministry region may be permitted more than 22 elected Board members; (4) Each cooperating association shall be represented by a minimum of one member from one of its cooperating churches; (5) No association may be permitted more than five Board members; (6) At least one elected Board member shall come from a church affiliated with the FBSC as a Church-at-Large; (7) In no instance will more than six elected Board members come from churches affiliated with the FBSC as a Church-at-Large, with no more than two Church-at-Large representatives coming from any one of the six ministry regions.
